ADVERTISEMENT

Applications in prescribed form are invited from the APST candidates for filling up of 1(one) reserved post of Field Publicity Officer (FPO) (Group 'B' Non- Gazetted under the Department of Finance, Govt. of Arunachal Pradesh in the pay band of Rs. 9300-34800/- plus Grade pay of Rs. 4600/- PM and plus other allowances as admissible to Arunachal Pradesh Govt. employees from time to time. The vacancy position is subject to variation.

(A) AVAILABILITY OF APPLICATION FORM:-

Applications Form and Attendance Sheet for admission to recruitment examination to the post of Field Publicity Officer can be obtained from the Commission's Office, Itanagar on all working days from **10. 00 AM to 4.00 P.M. up to 17.03.2017** on cash payment of Rs.100/-. No separate examination fee in the form of DD/IPO will be required along with the application. The examination fee has been included in the cost of application form.

Further, Application Form & Attendance Sheet can also be typed out or downloaded from Commission's website www.appsc.gov.in. and it can be sent by post enclosing required fee in the form of Demand Draft/IPO in favour of the Secretary, Arunachal Pradesh Public Service Commission, Itanagar . The envelope must be superscribed on its body "**Application form for the post of Field Publicity Officer**". Last date for receiving of application form for the post of Field Publicity Officer is on **17.03.2017** upto **4 PM**. Any application received after **4 PM** on **17.03.2017** shall be summarily rejected.


(B) ELIGIBILITY :-

Candidate must have attained 18 years of age and should not be more than 30 years as on **17.03.2017**. However, the upper age limit is relaxable to 5 years for APST candidates and another 5 years relaxation is admissible to APST candidates who are State Govt. employees.

(C) EDUCATIONAL QUALIFICATION:-

Candidates applying for the post must be a "Graduate in Arts /Science /Commerce from a recognized university "under Column 8 of the Recruitment Rules" includes the qualification of BA, B.Sc. B.Tech, LLB, MBBS, B.Com. etc. (Any Graduate from a recognized University).

However, the final year students who are to appear/had appeared in such examination shall also be eligible to apply provided that such candidates submit bonafide Student certificate along with the last semester mark sheet issued by the university. Candidates who are declared to have qualified by the Commission in the written competitive examination will have to produce original certificates or mark sheet of passing their degree examination issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University only on the day of Interview/Viva-voce. Without the original Certificate/Mark sheet they will not be allowed to appear in the Viva-Voce.

(D) METHOD OF SELECTION:-

The eligible candidate will have to appear in a written examination in the following subjects followed by Viva-voce/Interview to be conducted by the Commission at Itanagar. Total marks assigned to examination and viva-voce is as under:-

(I)	General Knowledge	=	100 marks
(II)	General English	=	100 marks
(III)	Mathematics(Class-X standard)	=	100 marks
(IV)	Viva –voce	=	<u>50 marks</u>
	Total	=	350 marks

The Candidates who secure minimum of 33% or more marks in each written examination papers and secure 45% marks out of aggregate total marks in the written examination papers shall be eligible for Interview/Viva-voce test. Number of the candidates to be called for Viva-voce shall be 1:3 with 1 being the number of posts advertised here and on the basis of total aggregate marks. The candidates securing less than 33% of marks in any of the written examination paper shall not be eligible for appearing in the viva-voce test.

NB:- The Commission may conduct a recruitment test (Objective Type) before written examination, if it is deemed necessary, if large number of applications are received.

(E) HOW TO APPLY:

Along with the duly filled up application, candidate must enclose the following documents.

- (i) 2(two) copies of recent colour pass- port size photographs with self attestation in the front side which should be pasted on the space provided in the application form and attendance sheet.
- (ii) Self Attested copies of certificates and marksheets issued by the Assistant Registrar/Registrar/Controller of Examination/Vice- Chancellor of the concerned University to ascertain educational qualification.
- (iii) Self Attested copy of Matriculation Certificate for proof of Age issued by the Board only will be accepted.
- (iv) Self Attested copy of Bachelor's Degree Certificate.
- (v) Self Attested copy of APST Certificate.
- (vi) The candidates who qualify for viva-voce test should produce original certificates from matriculation onwards upto Graduation level on the day of viva-voce test failing which they will not be allowed to participate in selection process under any circumstances.
- (vii) Copy of NOC from his/her controlling authority (In case of candidates already in the Govt. service under the Govt. of A.P. or any other government)

Applications shall be summarily rejected if :-


1. All the documents submitted by the candidates are not self attested or attested by Gazetted Officer.
2. Copy of any one or more documents as stated above, and applicable, is not enclosed with the application.

(F) LAST DATE FOR RECEIVING APPLICATION :

The last date for receiving Application by the Commission is **17.03.2017** up to **4.00 P.M.**

(G) OTHER CONDITIONS:

- (i) The decision of the Commission as to the eligibility or otherwise of a candidate for admission to the interview or Selection will be final and no correspondence or Personal enquiry will be entertained.
- (ii) Application in the prescribed form along with necessary documents should be submitted in the Reception counter in a Cover/Envelope super-scribed "Application for the post of Field Publicity Officer) and obtain receipt from the counter to ensure his/her submission of application form.
- (iii) The Commission will not be responsible for delay in receipt of application due to any reasons whatsoever.
- (iv) Application form not fulfilling the terms and conditions as stipulated in the advertisement will be rejected.


