ADVERTISEMENT

Applications are invited in prescribed format from the citizens of India for filling up of 4 (four) posts of Lecturer in Civil Engineering for Govt. Polytechnic of Arunachal Pradesh in the Pay Band-3 of Rs. 15600-39100 and Academic Grade Pay(AGP) of Rs. 5400/- (Pre-revised). Out of 4 posts, 3 posts are reserved for APST candidates and 1 post un-reserved i.e. (for open competition) as per Arunachal Pradesh Govt. reservation policy. Vacancy position and reservation of posts are subject to variation.

1. **EDUCATIONAL QUALIFICATION:** 1ST Class Bachelors Degree in Civil Engineering/Technology from a recognized university OR if the candidate has a Masters Degree in Civil Engineering/Technology, 1ST Class or equivalent is required at Bachelors OR Masters Level.

2. **AGE:** The candidate must not be less than 18 years and above 30 years of age as on **09.01.2018**. However, the upper age limit is relax-able in accordance with the orders issued by the Govt. of Arunachal Pradesh from time to time in respect of Arunachal Pradesh Scheduled Tribe candidates.

3. **METHOD OF SELECTION:** The eligible candidates will have to appear in an Interview/Viva-Voce test to be conducted by the Commission at Itanagar or any other place, which may be decided by the Commission. The final selection of the candidates will be made on the basis of the candidate's performance in the Interview/Viva-Voce purely on merit.

NOTE: *Commission will adopt Recruitment Test (Objective type) or any other means including academic performance to shortlist no. of candidates before the Interview/Viva-voce, if it is deemed necessary to do so.*

4. **AVAILABILITY OF APPLICATION FORM:** Application form and Attendance sheet are to be downloaded from the Commission's **Website www.appsc.gov.in**

5. **FEE:** Rs.100 for APST candidates and Rs.150/- for others in the form of DD/IPO in favour of Secretary, AP PSC, Itanagar, Arunachal Pradesh.


6. **HOW TO APPLY:** Along with the duly filled-up format, candidates must enclose the following documents other wise the application will be rejected summarily.

- (i) Self-attested copies of certificates and mark-sheets issued by the Assistant Registrar/Registrar/Controller Examination/Vice-Chancellor of the concerned University to ascertain marks and educational qualification.
- (ii) CGPA/GPA/Percentage/Class(Division) should be clearly visible and contained in the mark-sheet.
- (iii) 2(two) copies of recent pass-port size photographs with self-attestation in the front side of which one photograph should be pasted on the space provided in the Application form and another on the Attendance sheet.
- (iv) Self-attested copy of APST Certificate for APST and PRC/EPIC/Aadhaar Card for others.
- (v) Self-attested copy of Matriculation Certificate or equivalent for proof of age issued by the Board only will be accepted.
- (vi) Enclose original copy of DD/IPO of Rs.100/- for APST candidates and Rs.150/- for others.
- (vii) NOC/Intimation letter (self-attested) for those who are in regular Govt. service.
- (viii) All supporting documents submitted by the candidates must be **self-attested** or by a Gazetted Officer other-wise the application will be rejected.

7. **LAST DATE OF RECEIPT OF APPLICATION:** The last date for receiving of application form by the Commission is upto **09.01.2018** till **4 PM**. Application form received after closing date will not be accepted under any circumstances.

8. **OTHER RULES:**

- (i) The decision of the Commission as to the eligibility or other-wise of a candidate for admission to the interview or selection will be final and no correspondence or personal enquiry will be entertained.
- (ii) Candidates already in service may apply direct to this Commission with intimation to his/her Head of employer for doing so.
- (iii) Application in the prescribed form along with required documents should be submitted in the Reception Counter in a Cover/Envelope super-scribed "**Application for the post of Lecturer in Civil Engg, Polytechnic**" and obtain receipt from the counter to ensure his/her submission of application form.
- (iv) The Commission will not be responsible for delay in receipt of application due to any reason whatsoever.
- (v) Application form can also be sent "To the Secretary, Arunachal Pradesh Public Service Commission, Itanagar-791 111 (AP)" through registered post/courier and should reach the Commission before 4 P.M. on **09.01.2018**.
- (vi) Application form not fulfilling the terms and conditions as stipulated in the advertisement will be rejected.
