**ADVERTISEMENT**

Applications in prescribed form are invited from citizens of India for filling up of 19 posts of Assistant Engineer (Civil) under Public Work Department and 4 posts of Urban Programme Officer (UPO) under the Departments of UD & Housing, Govt. of Arunachal Pradesh in the pay of PB-3 Rs.15600-39100/- plus Grade Pay Rs. 5400/- P.M. plus other allowances as admissible to Arunachal Pradesh Govt. employees Group-A (Non-ministerial). Vacancy position is subject to variation. Any vacancy/post(s) if received from other engineering departments will be included.

**1. NO. OF POSTS:**

- (a) AP PWD ..... 19 posts (16 posts reserved for APST candidates of which 1 post reserved for PWD candidates exclusively for Blind/ Deaf and Dump) and 3 posts un-reserved i.e. for open competition.
- (b) UD & Housing .....4 posts (1 post reserved for PWD candidates and 3 posts Un-reserved i.e. for open competition)

2. **AGE:** The candidates must have attained 18 years of age and should not be more than 30 years of age as on **15.02.2016**. However, the upper age limit is relaxable in accordance with the orders issued by the Govt. of Arunachal Pradesh from time to time.

3. **EDUCATIONAL QUALIFICATION:** Candidate applying for the post must be a Bachelor of Engineering/Technology in Civil Engineering from a recognized University. However, the final year students of the Engineering degree courses who are to appear for such final examination shall also be eligible to apply. Such candidates who are declared to have qualified by the Commission in the written competitive examination will have to produce original certificates or mark-sheets of passing their degree examination issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University will only be accepted by the Commission on or before the date of Interview/Viva-voce. Without the original certificate/mark-sheet they shall not be allowed to appear in the Viva-voce.

4. **METHOD OF SELECTION:** The eligible candidate will have to appear in written examination in the following subjects followed by Viva-voce/Interview to be conducted by the Arunachal Pradesh Public Service Commission at Itanagar on the basis of which selection will be finalized.

The candidate who has secured a minimum of 33% or more marks in each written examination papers and has secured 45% of marks out of aggregate total marks in the written examination papers shall be eligible for Interview/Viva-voce test and on the basis of 1:3 ratio norms.

*Note: The Commission will adopt Recruitment Test (Objective type) before the written examination if it is deemed necessary to do so.*

**5. AVAILABILITY OF APPLICATION FORMS AND SYLLABUS:**

Application forms can be obtained from the Commission's office on all working days from **1000 hours to 1600 hours up to 15.02.2016** on cash payment of Rs. 100/- only in case of APST candidates and Rs. 160 /- only for General candidates. Further, Application form and Attendance sheet can also be typed out or downloaded from **Commission's Office Website [www.appsc.gov.in](http://www.appsc.gov.in)** and it can be sent through post enclosing required fee in the form of Demand Draft/IPO in favour of Secretary, Arunachal Pradesh Public Service Commission, Itanagar-791 111. The envelope must prescribe on its body "Application form for the post of Assistant Engineer (Civil), Last date 15.02.2016

6. **HOW TO APPLY:** Along with the dully filled-up format, candidates must enclose the following documents other-wise the application will be rejected.

- (i) Self-attested copies of Degree certificates and mark-sheets issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain educational qualification.

- (ii) 2 (two) copies of recent pass-port size photographs with self-attestation in the front side. (Your one self-attested photograph should be pasted on the space provided in the Application form and another on the Attendance sheet).
- (iii) Self-attested copy of APST certificate.
- (iv) Self-attested copy of Matriculation certificate for proof of age issued by the Board/University only will be accepted.
- (v) Self-attested copy of PRC/ST/SC certificate for the candidates belonging to other States of India.
- (vi) Copy of Demand Draft/IPO (for those form other obtained from Commission's Office).

7. **LAST DATE OF RECEIVING OF APPLICATION:** The last date for receiving of application form by the Commission is **15.01.2016**.

8. **OTHER RULES:**

- (i) All the documents submitted to the Commission must be self-attested.
- (ii) The decision of the Commission as to the eligibility or otherwise of a candidate for admission to the interview or selection will be final and no correspondence or personal enquiry will be entertained.
- (iii) Candidates already in service may apply direct to this Commission with intimation to his/her Head of Department.
- (iv) Application in prescribed form along with necessary documents should be submitted in the Reception counter in a cover/envelope superscribed, "Application for the post of Assistant Engineer (Civil)" and obtain receipt from the counter to ensure your submission of application form.
- (v) Application form received after the closing date or incomplete in any respect will be summarily rejected. Date of Birth as recorded in matriculation or equivalent certificate or Admit Card as issued by the Board only will be accepted.
- (vi) The Commission will not be responsible for delay in receipt of application due to any reason whatsoever.
- (vii) Application form can be sent through post/courier.
- (viii) Application form not fulfilling the terms and conditions as stipulated in the advertisement will be rejected.
