I am to state that the Commission had requested the Govt. for submission of requisition for recruitment to services / posts in various departments of the Govt. as per annual examination calendar as far back as 2007 vide Office Letter No. PSC-R/09/2007 dated 25th July' 2007. It has been observed that despite repeated reminders from the Commission requisitions are not being received as per the examination calendar circulated.

The Commission has reviewed examinations conducted by it in the last 2 (two) years. After a detail review it has been felt necessary to re-circulate a revised / modified annual examination calendar to the Govt. in order to facilitate the Govt. as also the Commission to proceed in a structured manner in the conduct of recruitment examinations. An annual examination calendar will also help the requisitioning authorities of the Govt. and the Commission to monitor progress of activities for timely remedial action, besides giving a clear picture of examinations likely to be conducted by the Commission to prospective candidates. You are, therefore, requested to pass on appropriate instructions to all Administrative Secretaries of the Govt. departments to ensure submission of requisitions as per examination calendar.
