ADVERTISEMENT

Application in prescribed format are invited from Arunachal Pradesh Scheduled Tribe Candidates for filling up of 2(two) posts of District Library and Information Officer (Libraries) Group'B' Gazetted (Non-Ministerial) under the Department of Libraries ,Govt. of Arunachal Pradesh in the Pay Band of PB-2 Rs. 9,300-34,800/-PM plus Grade Pay of 4600/-PM and other allowances as admissible to Arunachal Pradesh Govt. Employees from time to time. The 2 (two) posts are reserved for APST Candidates only. Vacancy position is subject to variation.

1.. Availability of application form and Syllabus:-

Application form alongwith the syllabus for admission to recruitment examination of the above posts can be obtained from the Commission's office, Itanagar on all working days from **10 AM to 4.PM** up to **16/05/2016** on payment of Rs. 100/- only for APST candidates .

Further Application form and Attendance sheet can also be typed out or downloaded from Commission's Website www.appsc.gov.in and it can be sent through post enclosing required fee in the form of Demand Draft/IPO in favour of the Secretary Arunachal Pradesh Public Service Commission, Itanagar. The envelop must prescribe on its body "Application form for the post of District Library and Information Officer, last date 16/05/2016 "

2. Age:-

A candidate must have attained 18 years of age and should not be more than 30 years of age as on **16/05/2016**. However, the upper age limit is relaxable in the accordance with the orders issued by the Govt of Arunachal Pradesh from time to time.

3. Educational qualification A candidate must be having Bachelor of Library Sc. from a recognized University. However, the final year students who are to appear for such final examination shall also be eligible to apply. Such candidates who are declared to have qualified by the Commission in the written competitive examination will have to produce original certificates or mark-sheets of passing their degree examination issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University will only be accepted by the Commission on or before the date of Interview/Viva-voce. Without the original certificate/mark-sheet they shall not be allowed to appear in the Viva-voce.

4. Method of Selection

The eligible candidate will have to appear in written examination in the following subjects followed by viva-voce test to be conducted by the Arunachal Pradesh Public Service Commission at Itanagar on the basis of which Selection will be finalized.

(i)	General English	=	100 marks
(ii)	General Knowledge	=	100 marks
(iii)	Library & Information Sc. (Paper-I)	=	100 marks
(iv)	Library & Information Sc. (Paper-II)	=	100 marks
(v)	Viva-Voce Test	=	50 marks
	Total		450 Marks

The candidates who secure a minimum of 33% or more marks in each written examination paper and 45% or more marks out of aggregate total marks in the written examination papers shall be eligible for viva-voce test. On the other hand, it will further mean that selection for viva-voce test shall be based on the aggregate total marks secured in the written examination papers and subject to ratio 1:3. The candidates securing less than 33% of marks in any of written examination paper shall not be eligible for appearing in the viva-voce test.

Note : The Commission will adopt Recruitment Test (Objective type) before the written examination if it is deemed necessary to do so.

5. **How to Apply :-** Along with the dully filled-up format, candidates must enclose the following documents other-wise the application will be rejected.


- (i) Self attested copy of Matriculation Certificate for proof of age issued by the Board/University only will be accepted.
- (ii) Self attested copies of Certificates and Mark sheets of Bachelor Degree issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain educational qualification.
- (iii) 2(two) copies of recent pass-port size photographs with self attested in the front side one on the application form and another on the attendance sheet.
- (iv) Self attested copy of Arunachal Pradesh Scheduled Tribe certificate.
- (v) No Objection Certificate/Intimation letter in case of candidates already in service.
- (vi) Copy of Demand/Draft/IPO (For those form other than obtained from Commission's Office).

6. **Last date for receiving of application.**

The last date for receiving of application form by the Commission is up to **16/05/2016** till 4 PM.

7. **Other Rules:**

- (i) The decision of the Commission as to the eligibility or otherwise of a candidate for admission to the interview or selection will be final and no correspondence or personal enquiry will be entertained.
- (ii) Candidates already in service may apply direct to this Commission with intimation to his/her present employer for doing so.
- (iii) Application in prescribed form along with necessary documents should be submitted in the Reception counter in a cover/envelope super scribed, "Application for the post of District Library & Information Officer" and obtain receipt from the counter to ensure his/her submission of application form. Application should be addressed to Secretary, APPSC, Itanagar Arunachal Pradesh.
- (iv) The Commission will not be responsible for delay in receipt of application due to any reason whatsoever.
- (v) Application form not fulfilling the terms and conditions as stipulated in the advertisement will be rejected
