ADVERTISEMENT

Applications in prescribed form are invited from Arunachal Pradesh Schedule Tribe for filling up 3 (three) posts of Joint Block Development Officer, Group- B (Gazetted), under the department of Rural Development, Govt. of Arunachal Pradesh in the pay band of Rs. 9300-34800/- Grade pay of Rs. 4800/- PM and plus other allowances as admissible to Arunachal Pradesh Govt. employees from time to time. The vacancy position is subject to variation.

[A] AVAILABILITY OF APPLICATION FORM.

Application forms for admission to recruitment examination of Joint Block Development Officer can be obtained from the Commission's office Itanagar, on all working days from 10 AM to 4 PM upto 16/02/2017 on cash payment of Rs. 100/- . No separate examination fee in the form of DD/Treasury challan will be required along with the application. The examination fee has been included with the cost of application form. On expiry of above mentioned last date of receiving application no further chance of correction/rectification will be given in any circumstance.

Further, application form and attendance sheet can also be downloaded from Commission's Website www.appsc.gov.in and it can be sent through post enclosing required fee of Rs.100/- in the form of Demand Draft/IPO in favour of the Secretary Arunachal Pradesh Public Service Commission, Itanagar. The envelope must be super-scribed its body " Application for the post of Joint Block Development Officer". Last date of receiving application is on 16/02/2017 upto 4 PM.

[B] ELIGIBILITY :-

The candidates must have attained 18 years of age and should not be more than 30 years as on 16/02/2017. However, the upper age limit is relaxable to 5 years for APST candidates and another 5 years relaxation to APST candidates for state govt employees.

[C] EDUCATIONAL QUALIFICATION :-

Candidate applying for the post must be a Degree holder in Arts or Science or Commerce from a recognized University .

2/1 However, the final year students who are to appear/appeared for such examination shall also be eligible to apply provided that such candidates are required to submit bonafide certificate along with last semesters marks sheet issued by the university. Candidates who are declared to have qualified by the Commission in the written competitive examination will have to produce original certificates or marksheet of passing their degree examination issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University only on the day of interview/Viva-Voce. Without the original certificate/Marksheet they will not be allowed to appear in the Viva-Voce.

[D] METHOD OF SELECTION :-

The eligible candidate will have to appear in written examination in the following subject followed by Viva-Voce/Interview to be conducted by the Commission at Itanagar on the basis of which selection will be made.

1. General English	-100 marks
2. General Knowledge	-100 marks
3. Mathematics (HSLC standard)	-100 marks
4. Viva-Voce test	- 50 marks

Total Marks -350 marks	

A candidate who has secured a minimum of 33 % or more marks in each written examination papers and has secured 45% of marks out of aggregate total marks in the written examination papers shall be eligible for Interview/Viva-Voce test. In other words, selection for viva-voce test shall be based on the aggregate total marks secured in the written examination papers and subject to ratio of 1:3. The candidates securing less than 33% of marks in any of the written examination paper shall not be eligible for appearing in the viva-voce test.

N.B The Commission will conduct recruitment test (Objective Type) before written examination, if it is deemed necessary to do so.

[E] HOW TO APPLY :-

Along with the duly filled up application, candidates must enclose the following self attested documents other wise the application will be rejected.

- i. 2 (two) copies of recent colour pass-port size photographs with self attestation in the front side which should be pasted on the space provided in the application form and attendance sheet.
- ii. Self Attested copies of certificates and marksheets issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain educational qualification.
- iii. Self Attested copy of Matriculation Certificate for proof of age issued by the Board only will be accepted.
- iv. Self Attested copy of APST certificate.
- v. The candidates who qualify for viva-voce test should produce original certificates from matriculation onwards upto Graduation level on the day of viva-voce test failing which they will not be allowed to participate in selection process under any circumstances.
- vi. Copy of NOC/Intimation letter from his/her controlling authority (In case of candidates already in the Govt. service under the Govt of A.P.
- vii. All the documents submitted by the candidates must be self attested or attested by Gazetted Officer otherwise their candidature will be **rejected**


[F] LAST DATE FOR RECEIPT OF APPLICATION :-

- c) Application in the prescribed form along with necessary documents should be submitted in the Reception counter in a Cover/Envelope super-scribed " Application for the post of Joint Block Development Officer" and obtain receipt from the counter to ensure his/her submission of application form.
- d) The Commission will not be responsible for delay in receipt of application due to any reason whatsoever.
- e) Application form not fulfilling the terms and conditions as stipulated in the advertisement will be rejected.


