ADVERTISEMENT

Application in prescribed form are invited from citizens of India for filling up of 108 (One hundred eight) posts of Medical Officer (Allopathy) and 03(three) posts of medical officer(Ayurveda), under the Department of Health & Family Welfare, Govt. of Arunachal Pradesh in the Pay scale of PB- 3 Rs. 15,600-39,100/- Plus Grade pay of Rs. 5400/- (pre-revised) (level 10 Rs. 56100-167300/- of pay matrix) P.M plus NPA as admissible under rule(s). The vacancy position are subject to variation.

ESSENTIAL QUALIFICATION :- As per schedule-V(III)(1)&(4) of General duty sub-cadre, APHS Rules,2000, Minimum education and other qualification for the post of GDMO (Allopathy/Ayurveda) as follows:-

1. **MEDICAL OFFICER(ALLOPATHY)**

A recognized medical qualification included in the First or Second Schedule or Part-II of the Third Schedule (other than licentiate qualification) of the Indian Medical Council Act, 1956. Holders of Educational qualification included in the Part-II of the Third Schedule should also fulfill the condition stipulated in sub-section (3) of section (13) of the Indian Medical Council Act, 1956.

2. **MEDICAL OFFICER(AYURVEDA)**

A recognized medical qualification in Ayurveda included in the second or third or fourth schedule to the Indian Medicine Central Council Act, 1970, as amended from time to time.

3. **Completion of compulsory rotating internship for both GDMO(Allopathy and Ayurveda). Candidates who may not have completed rotating internship shall be eligible to apply for the written examination or interview as the case may be, provided that at the time of actual interview, they shall have to produce proof of successful completion of the compulsory internship.**

The details of vacancy position and other criteria of both the recruitment are given below:

(A) GDMO(ALLOPATHY) (Total post & reservation) : For Recruitment to GDMO(Allopathy), out of 108 (one hundred eight) posts, 86 (eighty six) posts are reserved for APST candidates and 22(twenty two) are unreserved i.e., for open

competition. Out of 86 posts of GDMO(Allopathy) one post each is reserved for 3 categories of disability i.e.,(a) Blindness or Low vision, (b) Hearing impaired and (c) Locomotive disability or Cerebral palsy.

(B) GDMO(Ayurveda) (Total post & reservation) : For Recruitment to GDMO(Ayurveda), out of 03 (three) posts, 02 (two) posts are reserved for APST candidates and 01(one) is unreserved i.e., for open competition.

METHOD OF SELECTION :-

The eligible candidate will have to appear in written examination in the following subjects followed by Viva-Voce to be conducted by the Arunachal Pradesh Public Service Commission on the basis of which selection will be finalized.

(1) Papers-I:(code No.) 200 Marks(Allopathy)

- (i) General Medicine including Cardiology, Neurology, Dermatology and Psychiatry.
- (ii) Surgery including E.N.T. Ophthalmology, Traumatology and Orthopaedics.

(2) Papers-II :(code No.2) 200 Marks

- (i) Paediatrics
- (ii) Gynaecology and Obstetrics
- (iii) Preventive, Social and Community Medicine

(3) VIVA-VOCE: 50 Marks(12.5 marks)

- (i) Personality test and general aptitude
- (ii) General Medical Subjects for M.O. (Allopathy)

AND

(1) Papers-I(code No.1) :- 200 Marks(Ayurveda)

- (I) Kayachititsa-I,II,III,IV
(Practice of medicine in ayurveda).
- (II) Shalya(surgery) including shalakyas.
(E.N.T.Ophthalmology,dental), with Ayurvedic therapeutics.

(2) Papers-II (code No.2):- 200 Marks

- (i) Kaumarbrittya(Pedoatrics)
- (ii) Stree rogas and Prasuitantra
(Gynaecology and Obstetrics) with ayurvedic therapeutics.
- (iii) Swasthavritta(Preventive, Social and Community Medicine)

- (iv) Draya guna and Rasashastra(ayurvedic pharmacology)
- (v) Organon of medicine and philosophy,
(Padartha vigyan and Astanga sangraha)

(3) VIVA-VOCE: 50 Marks(12.5 marks)

- (iii) Personality test and general aptitude
- (iv) General Medical Science (Ayurveda)

The number of candidates who shall be called for personality test/viva-voce/interview will be in the ratio of 1:3 i.e. 3 candidates for one post as per merit in written examination, Subject to securing a minimum of 33% or more marks in each written examination papers and 45 % or more marks in aggregate out of total marks in the written examination.

(c) AVAILABILITY OF APPLICATION FORM AND SYLLABUS.

Application forms and syllabus for admission to recruitment examination of GDMO (Allopathy) and GDMO (Ayurveda) can be downloaded from the Commission's website www.appsc.gov.in from the date of advertisement and submitted to the commission on all working days from 10 AM to 4 PM upto **09-08-2017**

FEE-

Rs.120/- for APST and Rs. 180/- for others in the form of DD/IPO in favour of Secretary, Arunachal Pradesh Public Service Commission, Itanagar.

(D) AGE LIMIT :-

Not exceeding 30 years as on **09-08-2017** (Relaxable for SC/ST candidates by 5 years in accordance with instructions issued by the State Government).

(E) HOW TO APPLY :-

Along with duly filled up application, candidates must enclose the following documents otherwise application will be rejected.

- i. 2 (two) copies of recent colour pass-port size photographs with **self attestation** on the front size which should be pasted on the space provided in the application form and attendance sheet.
- ii. **Self attested** copies of certificates and marksheets issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain educational qualification.
- iii. **Self attested** copy of Matriculation Certificate for proof of age issued by the Board only will be accepted.

- iv. **Self attested** copy of APST certificate and copy of PRC in case of General candidates.
- v. **Self attested** copy of Arunachal Pradesh Medical Council Registration certificate/Medical Council of India and concerned State Medical Council certificate (Allopathy) and APIMC & concerned state council of Indian medical registration (Ayurveda).
- vi. All supporting documents submitted by the candidates must be **self attested** otherwise application will be rejected.
- vii. **PWD candidates should submit disability certificate obtained from State Medical Board. Such board should comprise a specialist of the particular category of disability for which the certificate is sought for failing which such certificate will be rejected.**

(F) LAST DATE FOR RECEIPT OF APPLICATION :-

The last date for receipt of application form by the Commission is **09-08-2017** upto 4 PM.

(G) OTHER RULES :-

- a) The decision of the Commission as to the eligibility or otherwise of a candidate for admission to the interview or selection will be final and no correspondence or personal enquiry will be entertained.
- b) Candidates already in service may apply direct to this Commission with NOC from his/her Head of Deptt.
