**NOTIFICATION**

The Governor of Arunachal Pradesh is pleased to order framing of Syllabus for written examination for the post of **Prosecuting Officer** under Home Department, Government of Arunachal Pradesh. Detailed Syllabus is as under:-

**1. General English: 100 Marks.**

- (a) Essay writing/Letter writing/Précis writing/Expansion.
- (b) English Usage: Sentence Composition, Sentence Correction, Transformation of Sentences. Verbalize Correctly, Idiomatic Language, Punctuation.
- (c) Comprehension: Finding Specific Details, Drawing Inferences, Application to other Situations, Tone/Attitude, Meaning, and Vocabulary Based Questions in Reading Comprehension.

**2. Indian Penal Code: 100 Marks.**

- (a) General Exceptions and Right of Private Defence.
- (b) Abetment and Criminal Conspiracy.
- (c) Offences against the State and Public Tranquility.
- (d) Offences by or relating to Public Servants, Contempts of Lawful Authority of Public Servants and False Evidence, Offences against Public Justice.
- (e) Offences affecting human body/Life-Murder, Attempt to Murder, Dowry Death, Hurt, Grievous Hurt, Wrongful Restraint/Confinement, Criminal Force, Assault, Kidnapping, Abduction, Slavery, Forced Labour, Rape, Unnatural Offences.
- (f) **Offences against Property**-Theft, Extortion, Robbery, Dacoity, Criminal Misappropriation of Property, Criminal Breach of Trust, Receiving Stolen Property, Cheating, Mischief, Criminal Trespass.
- (g) **Offences relating to Documents**- Forgery, Using a False Trade Mark, Offences relating to Currency Notes/Bank Notes.
- (h) **Offences relating to Marriage**, Cruelty by Husband or Relatives of Husband.
- (i) Defamation, Criminal Intimidation and Annoyance.

**3. Criminal Procedure Code: 100 Marks.**

- (a) Constitution of Criminal Courts and Offices, Power of Courts.
- (b) Process to Compel Appearance: Summons, Warrant of Arrest, Proclamation and Attachment, Process to Compel the Production of things.
- (c) Security for keeping the Peace and for Good Behaviour, Maintenance of Public Order and Tranquility: Unlawful Assemblies, Public Nuisance, Urgent Cases of Nuisance or Apprehended Danger, Disputes as to Immovable Properties.
- (d) Information to Police and their Power to Investigate.
- (e) Jurisdiction of the Criminal Courts in Inquiries and Trials, Conditions requisite for Initiation of Proceedings, Complaints to Magistrates, Commencement of Proceedings before the Magistrates, Charge: Form of Charges, Joinder of Charges.
- (f) **Trials:** Sessions Trial, Warrant Trial, Summons Trial, Summary Trial.
- (g) Evidence in Inquiries and Trials and its General Provisions, Provisions as to Accused Persons of Unsound mind, Transfer of Cases.

- (i) Provisions as to Bail and Bonds.

**4. Constitutional Law: 100 Marks.**

- (a) **Nature of Indian Constitution:** Historical Background, Outstanding features, Citizenship, Fundamental Rights and Duties, Directive Principles of State Policy, Procedure for Amendment.
- (b) **Govt. of the Union:** President/Vice President, Council of Ministers, Attorney General of India, Union Legislative.
- (c) **Govt. of the States:** Governor, Council of Ministers, Advocate General, Union Legislative.
- (d) **The Judiciary:** Supreme Court, High Court.
- (e) **The Federal System:** Distribution of Legislative and Executive Powers, Distribution of Financial Powers, Administrative Relations between the Union and the States, Inter-State Relation, Emergency Provisions.

**5. Jurisprudence: 100 marks**

- (a) Nature and Scope of Jurisprudence and Schools of Jurisprudence.
- (b) **Law in General and its kinds:** Sources of Law, Civil Law, Administration of Justice, State and Sovereignty.
- (c) **Legal Rights:** Ownership, Possession, Persons, Title, Liability, Obligation.
- (d) Law of Property.

**5. Code of Civil Procedure: 60 marks.**

- (a) **Suits in General:** Jurisdiction of the Courts, Res-judicata, Place of Suing, Institution of Suits, Summons and Discovery.
- (b) **Execution:** Courts by which Decrees may be executed, Questions to be determined by Courts Executing Decrees, Limit of time for Execution, Transferees and Legal Representatives, Arrest and Detention, Attachment, Sale, Distribution of Assets, Resistance to Execution.
- (c) **Suits in Particular cases:** Suits by or against the Govt. of Public Officers in their Official Capacity, Suit by Aliens and by or against Foreign Rulers, Ambassadors and Envoys, Suits against Rulers of former Indian States, Inter Pleader, Arbitration.
- (d) Appeals, Reference, Review, Revision.

**7. Juvenile Delinquency Act: 40 marks.**

- (a) Child and the Juvenile Justice Law in India.
- (b) Child's Rights and Principles of Juvenile Justice.
- (c) Children in need of Care and Protection: Child Welfare Committee, Observation Homes, Special Homes, Children Homes.
- (d) **Children in Conflict with Law:** Juvenile Justice Board and its Powers/Functioning.
