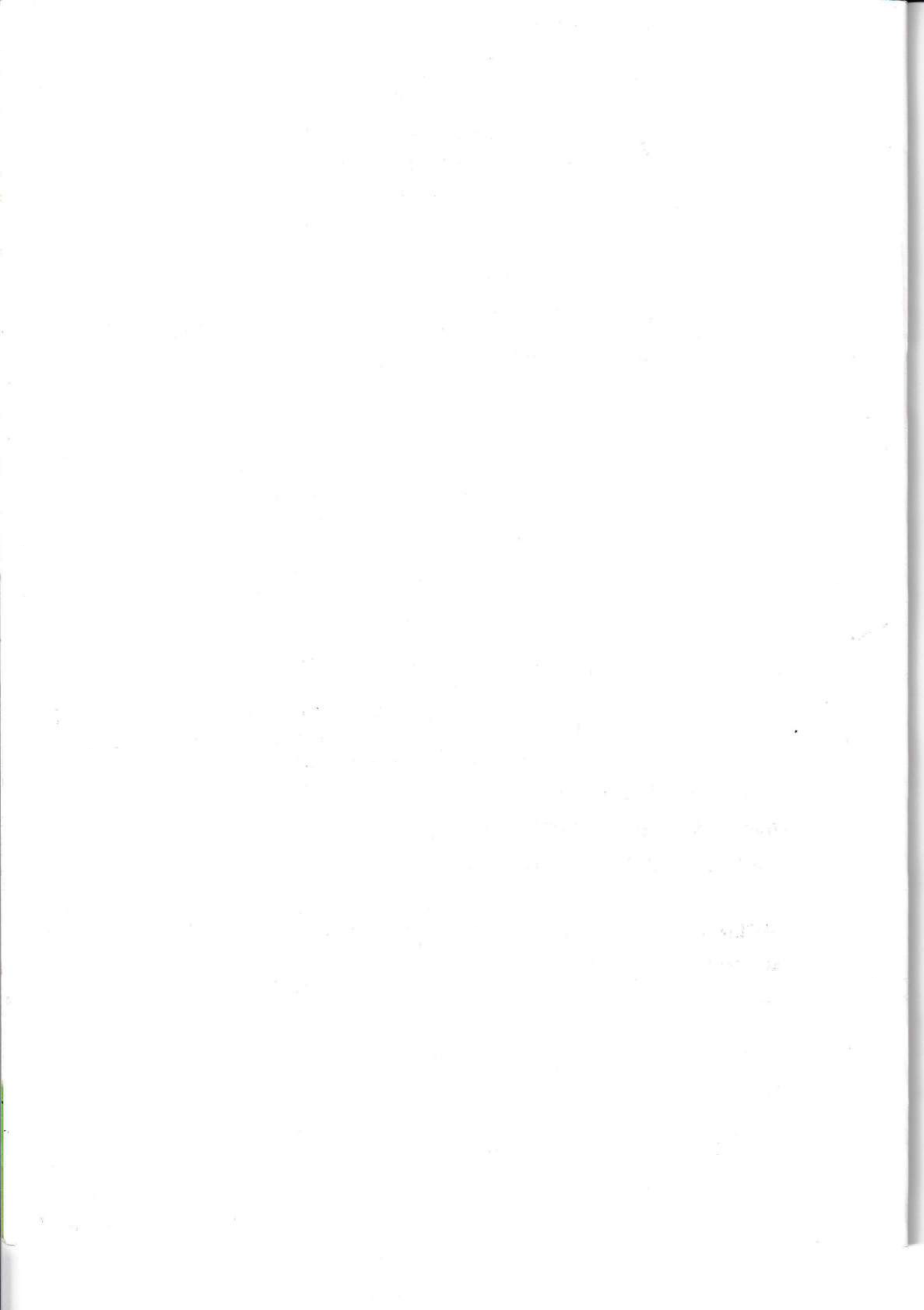

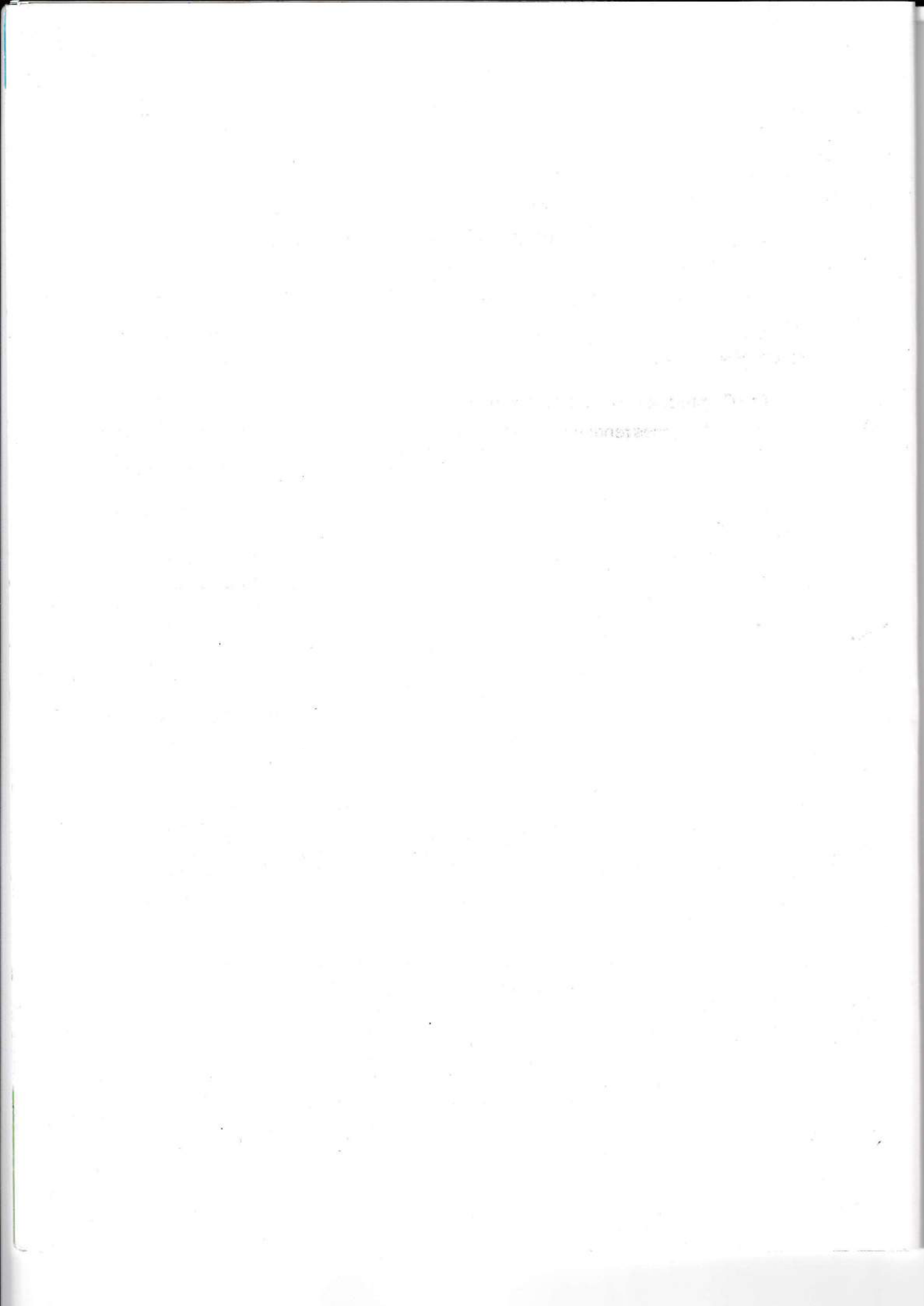

(c) Duties & Functions

Article 320 of the Constitution of India, requires the Commission to conduct examination for appointment to various services of the State of Arunachal Pradesh. The Commission is also required to be consulted on:-

- (i) Matters relating to method of recruitment to Civil Services/posts.
- (ii) The principles to be followed in making appointment to Civil Services and posts and in making promotion and transfer from one service to another and on suitability of candidate for such appointment, promotion and transfer.
- (iii) Disciplinary matters affecting person(s) serving under the State Government in civil capacity including related memorials or petitions.
- (iv) Any claim payable, out of the Consolidated Fund of the State, to a person serving under the State Government in Civil capacity, towards the cost incurred by him in defending legal proceedings instituted against him for acts done or purported to have been done in execution of his duty.
- (v) Claims for award of pension in respect of injuries sustained by a person while serving under the State Government in Civil capacity and any question as to the amount of such award.

PART - II

a. Visit By Chairman/Members

Shri Nipo Nabam, Hon'ble Chairman and Shri Tsering Naksang, Hon'ble Member, Arunachal Pradesh Public Service Commission attended Workshop on Interview Techniques by UPSC, New Delhi on 28th & 29th August, 2018.

b. Conference & Official Visits

Shri Nipo Nabam, Hon'ble Chairman, Arunachal Pradesh Public Service Commission attended the 21st National Conference for Chairpersons/Members of all State Public Service Commissions held from 4th to 5th February, 2019 at Bhubaneswar.

c. The Commission's Secretariat

The Commission's Secretariat is headed by Secretary. The Secretary's office has two separate divisions to deal with the Recruitment and Establishment matters each functioning under a Joint Secretary level officer.

The Recruitment matters of the Commission is headed by Joint Secretary-cum-Controller of Examinations (CoE) and is assisted by a Deputy Secretary-cum-Dy. CoE, an Under Secretary-cum-Asstt. CoE and 2 (two) Section Officers. The Recruitment Branch is divided into two Sections viz. – 'A' and 'B'.

The Establishment Branch is headed by Joint Secretary (Establishment)-cum-DDO and is assisted by a Deputy Secretary (Establishment), an Under Secretary (Establishment) and a Section Officer (Establishment).

d. Staff Strength of the Commission

The sanctioned strength of the staff of the Commission is appended at Appendix-'B'.

e. Organizational Chart

The Organization Chart is appended at Appendix-'C'.

f. Infrastructure (Building)

The Commission's Office is housed in a double storied building allotted by the Government of Arunachal Pradesh which was meant for Administrative Training Centre. A new building for holding recruitment examinations with seating capacity of 920 (nine hundred twenty) has been added to the existing building. CCTV and Mobile Jammer to detect impersonation and malpractices adopted by the candidates have also been installed in the Examination Halls. Installation of CCTVs in the Interview rooms is under consideration by the Commission in view of order of Hon'ble Supreme Court of India.

g. Finance

Budget Grant and Expenditure:-

During the year reported upon, Government allotted a sum of ₹ 9,18,60,000 (Rupees nine crore eighteen lakhs sixty thousand) only in the budget estimate for the Commission. The total expenditure during the year was ₹ 9,17,18,900 (Rupees nine crore seventeen lakhs eighteen thousand nine hundred) only. The balance amount of ₹ 1,41,100 (Rupees one lakh forty-one thousand and one hundred) only was surrendered.

PART – VIII

NEW INITIATIVES

UPSC Pattern of Combined Competitive Examination.

The Commission submitted proposal for notification of fresh Arunachal Pradesh Public Service Combined Competitive Examination Rules in place of the existing one notified in 2001 for adoption of UPSC pattern and examination for Combined Civil Services Examination conducted by it vide No. PSC-44/2017 dated 18/01/2018. The Commission had followed up with the Government, with some additional inputs, for expediting the notification process as proposed above vide even No. dated 4/10/2018. Subsequently, another reminder was sent vide even No. dated 30/01/2019. The Commission is constantly in touch with the Government for early notification of Arunachal Pradesh Public Service Combined Competitive Examination Rules, 2019.

Online Application & Registration

The Commission submitted a proposal to the IT Department for development of Online Application and Registration System (OARS) for the Commission by taking cue from other Public Service Commissions. Proposal has been submitted to the Department of Information Technology vide letter No. PSC-24/2018 dated 31st July, 2018. The overall objective of the Online Application and Registration System is to develop an automated registration process and provide user friendly access to the candidates for registration. Through this system once a candidate takes registration, he/she will be provided with user ID and he/she can generate his/her own password. The candidates can update his/her information and data by using his/her user ID and password any time. The relevant information uploaded in the website will be automatically available for the data required for any post for which the candidate applies in future. The IT department, after necessary process of tendering etc., has awarded the work to a firm and now is in the final stage. It is expected to be launched shortly.

Improvement in Setting Guidelines, description and pattern of questions

The Commission has taken steps to improve upon the functioning of the Commission by infusing new ideas and methodologies of the examination process of question setting, evaluation and conduct of interview to make the system transparent and fool proof. The Commission is also making efforts to improve its functioning by adopting best practices used by other State Public Service Commissions. The Secretary has visited some NE State PSCs with a view to learn about the best practices adopted by them and replicate in the APPSC wherever feasible. Some best practices adopted by other State PSCs & UPSCs are under active consideration of the Commission.

CCTV installation in Exam Hall of Commission

All the Examination Halls in the Commission are installed with CCTVs. CCTVs will also be installed in all the Interview Rooms in pursuance of Hon'ble Supreme Court's order relating to installation of CCTV cameras in the interview rooms.

PART – IX

Right To Information Act, 2005

Under the provision of RTI Act, 2005 this Commission has been providing authenticated information to applicants by allowing candidate to apply in person for his/her answer scripts.

With a view to enhance public confidence in the Commission and to ensure transparency, the results are declared on the last day of interview and the marks of the written examinations plus marks in interview (viva-voce) of all the qualified candidates are displayed, suo moto, on the website.

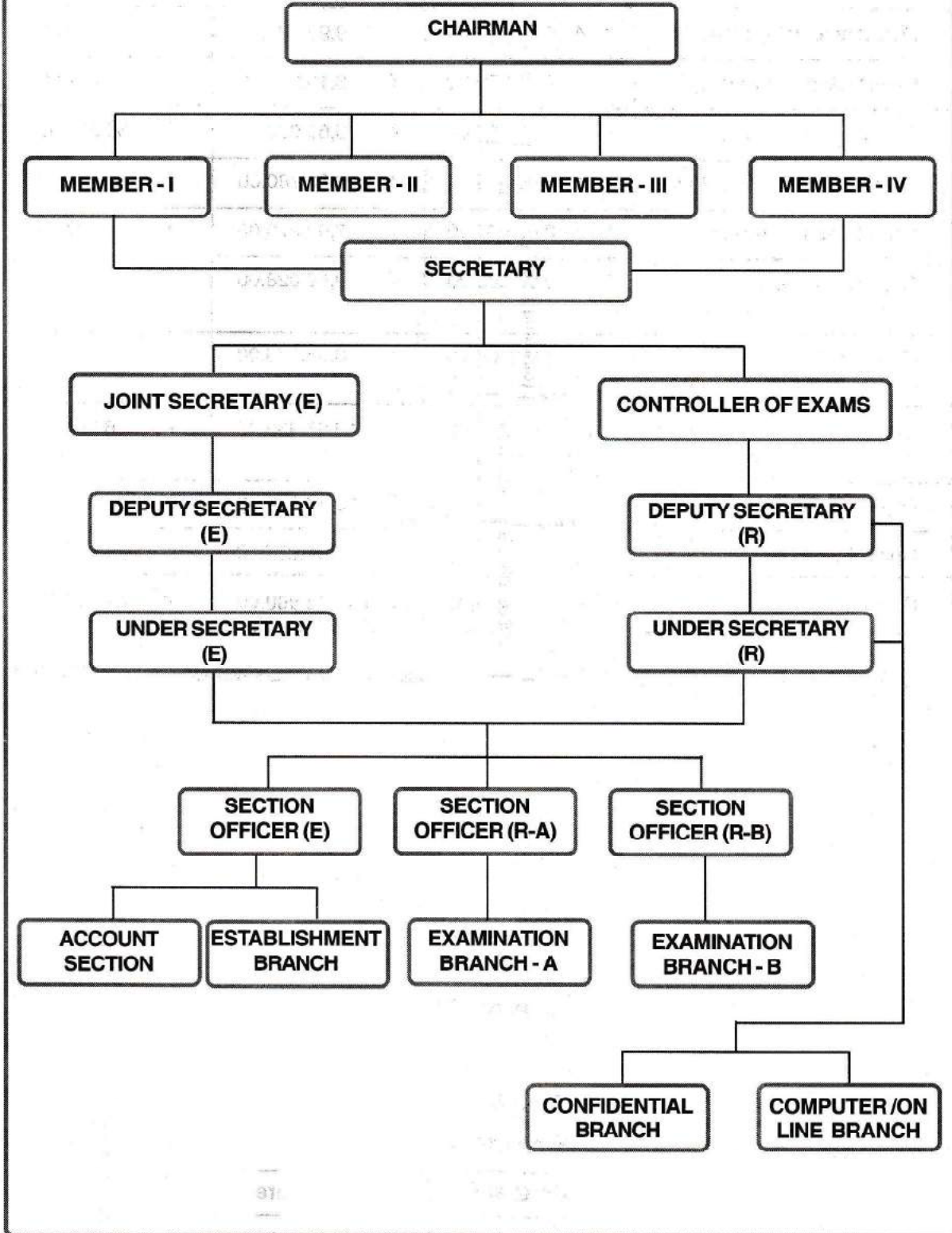
