#### **PREFACE**

The Year 2019-20 has been an eventful year. The Commission itself saw some major turnovers. One vacant post of 'Member of the Commission' was filled in January 2020 with the appointment of Maj Gen Ganesh Singh Bisht, VSM(Retd). This is the first time that a person from the Armed Forces has joined the Commission. The Secretariat also witnessed a change with Shri A.R. Talwade, IAS, joining as the Secretary of the Commission.

This year witnessed recruitment to 700 posts, requisitioned by the Government of Arunachal Pradesh and various Departments. Of these, 619 posts were selected through Competitive Examinations(Written Examination followed by Interview/Viva-voce) & 81 posts, through Interview/Viva-voce only. **This is the highest ever number of posts recruited by the Commission in one year**. It entailed scrutinising 33,412 applications, conducting 11 written examinations involving 14,013 applicants and interviewing 3,373 candidates for various posts/services of different Departments of the Government. That, this record recruitment was accomplished efficiently and without any blemish, reflects the commitment of the Commission to fully meet the aspirations of not only the Government, but also the Applicants and the Citizens at large.

A long pending issue of the Arunachal Pradesh Public Services Combined Competitive Examination (APPSCCE) - 2017, for selection of 104 posts, that went into litigation, appears to be reaching its logical conclusion. A Division Bench of the Guahati High Court has found the Commission's processes legally correct, over ruling the earlier judgement of the Court's Single Bench. The Commission has been directed to complete the selection process within a month, which the Commission is poised to accomplish.

The Commission constantly endeavours to evolve its processes and procedures to make them contemporary and transparent. To this end, some recent developments are noteworthy. For the conduct of Arunachal Pradesh Public Services Combined Competitive Examinations (APPSCCE) -2020, the Commission has approved adoption of the UPSC pattern of Civil Services Examination, with common papers/syllabus in both the Preliminary and Mains (Written) Examination, except for one optional subject in the Mains (Written) Examination. This will greatly help young aspirants, who will now have a common syllabi for preparation of Civil Services, both at State and Central levels. The Commission has also introduced a system of 'One Time Registration' on the

Commission's newly refurbished website (appsc.gov.in), so that the general data of Applicants, who, overtime apply for different posts/services advertised, automatically gets captured in any fresh application. This innovation, combined with our decision to only accept applications online, will bring in much needed efficiency in the process of scrutiny of applications.

The Commission is yet to get its Permanent Office building. The project has been approved for it to come up in location, after demolition of the existing temporary structure. To facilitate the same, the Commission is currently functioning from the Guest House building. We are hopeful that the Government will soon provide the requisite funds so that the project can commence earliest.

The Commission's effectiveness is also a reflection on the excellent support that it has received from the State Government and the Heads of various Departments. Our gratitude is also due to the Heads and Staff of various Educational Institutions, within the State and outside; without whose active support, the Commission would not be able to function. And finally, the Commission would like to convey its appreciation to the Chief Secretary and other Officers in the Government, who have cooperated with a sense of commitment, to ensure that the Commission is able to accomplish its mandate and earn the trust and respect of the people of the State.

#### **CHAPTER-1**

#### **GENERAL**

#### 1.1 Brief History

The Arunachal Pradesh Public Service Commission was established on 1st April1988 under Article 315 of the Constitutionof India, with Shri T.S.Deori as its first Chairman and Shri M.R. Das, IAS(Retd.) & Shri Y. Tikhak as its first two Members. The Commission today consists of a Chairman, four Members and is served by a Secretariat. Arunachal Pradesh Public Service Commission Regulations No. OM-15/88 dated 29 March 1988, as amended from time to time, governing functioning of the Commission.

Till recently, the Commission was functioning from a temporary office building, allotted by the State Government, earlier meant for the Administrative Training Centre. A new building for conducting examinations, with a capacity of 920 seats was added in 2018. A Guest House has come up alongside this year. Since February 2020, this guest house has been converted into the Commission's office, pending construction of it's permanent office, that has been approved and hopefully, will come up shortly in the same premises.

#### 1.3. Vision and Mission

The Commission has set itself the following Vision and Mission:

#### **1.3.1** Vision

The Arunachal Pradesh Public Service Commission is mandated by the Constitution of India to recruit the most 'meritorious' personnel to the Arunachal Pradesh Government. However, more than the popular perception of being a recruiting organisation for government jobs, the Commission envisages its significance as an important element in the process of governance and success of democracy. It safeguards the hopes and aspirations of millions of aspirants for government jobs, that rests on the effective functioning of this body. Therefore, **Reliability**, **Validity**, **Transparency and above all Citizens' Trust must be the Commission's calling cards.** 

#### **1.3.2. Mission**

The Arunachal Pradesh Public Service Commission aims at consolidating public trust by creating and nurturing a Public Service that is **Independent, Impartial, Ethical, Effective and Capable** enough to meet contemporary challenges faced by the Government and is responsive to the growing expectations of the citizens at large.

#### 1.4. Charter of Duties

Under Article 320 of the Constitution of India, the Commission is, interalia, required to be consulted on all matters relating to recruitment of civil services and posts. Currently the commission performs the following duties:

- (a) Direct recruitment through written examinations for appointment to the services of the state.
- (b) Direct recruitment through interviews.
- (c) Framing and amendment of Service and Recruitment Rules including Examination Syllabi for various services and posts under the Government of Arunachal Pradesh.
- (d) Advising the Government of Arunachal Pradesh on any matter referred to the Commission by Hon'ble Governor of Arunachal Pradesh.

The responsibility for appointment of State Civil Services Officers on promotion/deputation/absorption and disciplinary cases related to these Officers is currently retained by the State Government.

#### **CHAPTER - 3**

#### RECRUITMENT

#### 3.1 Direct Recruitment (by Written Examinations and Interviews)

For Services/Posts, recruitment for which is mandated through a Written Examinations followed by an Interview, the Commission follows under mentioned process/procedure.

After a valid requisition for a Service/Post is accepted by the Commission, advertisement for the same is uploaded on the Commission's website <a href="http://appsc.gov.in">http://appsc.gov.in</a> after due scrutiny. The advertisement is published in a number of national and regional newspapers. It is also communicated to Government Departments and Heads of Institutions for wider dissemination. The advertisement apart from other aspects gives out the name of Requisitioning Department, Number of Posts, Reserved Posts for Arunachal Pradesh Scheduled Tribes (APST) and for Persons with Disabilities(PwD), Dates for the Written Examinations and Last Date/Time by which applications would be received at the Commission. Applications are now invited only online and a new facility for 'One Time Registration' for applicants has been introduced in the newly designed website of the Commission to facilitate the aspirants. Data once captured is then automatically picked up in all future applications of the applicants.

If the number of applicants is substantively more than the posts advertised for, the Commission invariably conducts a Preliminary Examinations to shortlist serious candidates. The Preliminary Examination is Objective Type in nature and assists the Commission to shortlist the applicants roughly 12 times the advertised posts.

The Main Examination can be Subjective/Objective Type depending on the syllabi. After the Mains, applicants approximately three times the number of posts advertised for, are invited for Interview. The final merit list is made after combining the marks of the Written (Mains Exam) and Interview by taking into consideration, reservation policy in vogue. Currently, 80% of the posts are reserved for Arunachal Pradesh Scheduled Tribes(APST) and 4% for Persons with Disabilities (PwD) applicants.

The merit list/selection list is uploaded on the Commission's website soon after the completion of interview process and also released to various newspapers.

#### 3.1.1 Selections Finalised (by Written Exam and Interview).

In the year 2019-2020, the Commission screened Applicants for a total of 619 posts through a process of written exams and interviews. Summary is as follows:




#### 3.3 Recruitment by Limited Departmental Competitive Examination.



#### 4.2 Court Cases


Owing to the nature of the functions performed by the Commission, confronting Court Cases is integral to the functioning of the Commission. The efforts required is compounded by the fact that the Commission does not have its own Law Branch/Law Officer and has to depend largely on the Advocate General/Law Officers of the State. However, it's a matter of satisfaction and pride that owing to the stringent adherence to Constitutional Provisions, SOPs and guidelines and utmost transparency in its functioning, most of the court cases have been ruled in favour of the Commission at various courts of appeal.

Particularly significant favourable decisions in this regard, have been in two recent cases, W.P. (C) 604/2018 Tajing Taggu & Ors. Vs APPSC & Ors and W.P. (C) 636/2018 Remi Mize & Ors. Vs APPSC & Ors, in which the petitioners had challenged and won a Single Judge verdict in the Guahati High Court against conduct of the APPSCCE 2017 examination, that was appealed to against, by the Commission. A Division Bench of the same Court ruled on 06.03.2020, in favour of the Commission, finding its processes in order and setting aside the single bench judgement. It has directed the Commission to complete the examination process at the earliest, possibly within a month of the Judgement. The process is now expected to be completed by the first week of June 2020, bringing-in much relief to both; the applicants and Government of Arunachal Pradesh.



#### 4.3 Case Related to Right to Information (under RTI Act 2005).





#### **CHAPTER - 6**

#### MISCELLANEOUS ACHIEVEMENTS, INITIATIVES AND ACTIVITIES

#### 6.1 Achievements and Initiatives

#### 6.1.1. Introduction of UPSC Pattern of Examination for Recruitment to Arunachal Pradesh Public Services (APPSCCE)

In the existing pattern for conduct of APPSCCE, specially the Preliminary Examination, there was extreme complexity in evaluation of the candidates owing to a large number of optional subjects that had to be equated and homogenised resulting in numerous representations and court cases based on interpretation of individual applicants. Setting and evaluation of question papers was also a logistical challenge for the Commission. Therefore, to ameliorate the situation, with effect from APPSCCE 2020, the Commission has proposed and obtained acceptance of the Government of Arunachal Pradesh, to adopt the UPSC pattern of Civil Services examination. This will greatly assist the applicants who will now have a common syllabus to prepare for Civil Services Examination, both at the State and Union Public Service Commission levels. Requisite Recruitment Rules and Syllabi have been formulated and notified.

#### 6.1.2 Shift to 'Only Online Applications' and Introduction of the facility of 'One Time Registration' for Applicants

The Commission has always strived to be contemporary and transparent. To this end, in collaboration with IT department of the State, a system of 'Online Applications' and 'One Time Registration System' (OARS) for applicants desirous of applying for government jobs, advertised by the Commission, has been introduced on the Commission's Website. The Online Application and Registration System (OARS) is an automated registration process and provide the applicants, user friendly access for registration. Through this system, once a candidate registers himself/herself once, he/she will be provided with a User ID and he/she can generate his/her own Password. The applicants can then update his/her information and data any time. The relevant

information is then automatically captured in all his/herfuture applications. The system has not only facilitated the applicants, it has greatly reduced the workload on the Commission's staff in terms of scrutiny of applications. The Commission has now switched to accepting only online applications.

#### 6.1.3 CCTV Coverage of Examination and Interview Process.

The Commission has introduced the system of CCTV surveillance of all the examination and interview processes in its campus.


