**ADVERTISEMENT**

Online applications are invited from Arunachal Pradesh Schedule Tribe (APST) candidates for filling up of 21 (twenty one) posts of Senior Personal Assistant (Sr.PA) [(Group 'B' Non-Gazetted) Ministerial] under following Offices/Departments in the Pay Matrix Level - 6 Rs.35400 - 112400 PM plus other allowances as admissible to Arunachal Pradesh Govt. Employees from time to time. The vacancy position and reservation of post is subject to variation.

**1. Eligibility :-**

- I. A candidate shall not be less than 21 years and not more than 32 years of age as on **11-04-2020**. However, age relaxation will be as per Government rules and regulations in force from time to time.
- II. The Candidate applying for the post must hold Bachelor's degree or equivalent from a recognized university.
- III. Speed of 100 words per minute in Stenography (English)
  - (a) Dictation :- 10 mts @ 100 WPM
  - (b) Transcription :- 50 mts (English), Skill test shall be done in computer. An average of 5 key depressions for each work.
  - (c) 5% permissible mistakes in transcription would apply in speed test.

**2. Method of Examination :**

The eligible candidates will have to appear in written examination in the following subjects and viva-voce to be conducted by the Arunachal Pradesh Public Service Commission, Itanagar.

(a) General English	-	100 Marks
(b) General Knowledge	-	100 Marks
(d) Stenography	-	100 Marks
(e) Viva-voce	-	<u>40 Marks</u>
<b>Total</b>	-	<b>340 Marks</b>



The candidate who secured a minimum of 33% marks or more in each written examination papers and 45% or more marks out of aggregate total marks in the written examination papers will be eligible for Viva-voce. On the other hand, it will further mean that selection for viva-voce shall be based on the aggregate total marks secured in the written examination papers and subject to ratio 1:3. The candidates securing less than 33% of marks in any of written examination paper shall not be eligible for appearing in the viva-voce.

**NOTE :** *The Commission will adopt Recruitment Test (Objective Type) before the Stenography speed test and written examination if it is deemed necessary to do so.*

**3. Fee :-** Candidates are required to pay fee of Rs. 100/- (Rupees one hundred) only through online mode.

**4. How to Apply:** Candidates are required to apply Online only through the website [www.appsc.gov.in](http://www.appsc.gov.in). Instructions for filling up Online application are available on the above mentioned website.

**Scanned copies of following documents/information are to be attached/uploaded.**

- (i) Scanned Signature of the candidate on white paper with black ink pen (20-60 kb in jpg format).
- (ii) Latest/Recent passport size photo (40 – 100 kb in jpg format).

**5. The candidates declared to have qualified in written examination will have to submit Xerox copies of the following documents/information to the Commission before date of interview.**

- (i) Class X Certificate issued by Board/University.
- (ii) Degree Certificates with mark sheet issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain educational qualification.
- (iii) APST Certificate.
- (iv) Intimation letter to HoD / NOC in case of candidate already in Govt. service.
- (v) Disability Certificate from competent Medical Board only in case of PwD candidate.


*Qualified candidates will have to produce the above mentioned Certificates/Documents and mark sheet in ORIGINAL at the time of interview/viva-voce.*


