**NOTIFICATION**

This is for information to all concerned that the Arunachal Pradesh Public Service Commission, Itanagar had declared the written examination result of Arunachal Pradesh Public Service Combined Competitive Examination (APPSCCE) 2017-2018 on 06-03-2020 following the judgement of Hon'ble High Court, Guwahati. Subsequently the Interview/Viva-voce Test was scheduled w.e.f. 29-03-2020 to 02-04-2020.

Further, the Physical Efficiency Test for the aspiring candidates for the post of APPS/Deputy Superintendent of Police was conducted on 18<sup>th</sup> & 19<sup>th</sup> March 2020 and the Medical Examination was scheduled to be held from 23<sup>rd</sup> to 25<sup>th</sup> March 2020. However, in view of its deferment by the the Chief Medical Superintendent, TRIHMS vide Order No. TRIHMS/DEV-12/83/2013/PT/6971 dated 23-03-2020 and State Government's Order No. Secy (H&FW)/5/1/2020 Dated 22-03-2020 in the wake of precautionary measures taken to contain COVID-19 pandemic, the Commission has taken a decision to postpone the ensuing Medical Test which was scheduled w.e.f. 23-03-2020 to 25-03-2020 and Interview/Viva-voce Test which was scheduled w.e.f. 29-03-2020 to 02-04-2020 until further orders.


