The Arunachal Pradesh Public Service Commission invites application for filling up of 25 (Twenty Five) posts of Assistant Section Officer through Limited Departmental Competitive Examination (LDCE) from following candidates:

- (1) Upper Division Clerks of the District Ministerial Cadre who have completed 6 (six) years of regular service in the grade and possessing graduation in any discipline from a recognized university.
- (2) Senior Secretariat Assistants of the Arunachal Pradesh Secretariat Clerical Service Cadre who have completed 6 (six) years of regular service in the grade and possessing graduation in any discipline from a recognized university.

#### (A) ELIGIBILITY CRITERIA

- Bachelor Degree/ Graduation in any discipline from a recognized university. (1)
- (2)Completed 6(six) years of regular service in the grade of Upper Division Clerk of the District Ministerial Cadre or Senior Secretariat Assistant of the Arunachal Pradesh Secretariat Clerical Service Cadre
- Possessing at-least **five** 'Very Good' consecutive ACR/ APAR grading for the last 5 (3) (five) years.

### (B) HOW TO APPLY

- (1) Application Form is available for download in the APPSC website https://appsc.gov.in. The duly filled-in application form must be recommended by the Cadre Controlling Authority along with details of the ACR/ APAR grading of last five consecutive years.
- (2) Only applications nominated by the Cadre Controlling Authority with at-least five 'Very Good' consecutive ACR/ APAR grading of last 5 (five) years shall be considered.
- (3) The duly filled-in application forms nominated by the Cadre Controlling Authority must also enclose the documents listed herein at (E).
- (4) All such duly nominated applications must be submitted in the office of APPSC on or before 30th October 2025 (Thursday) by 3:00 pm.

## (C) METHOD OF SELECTION

The eligible candidates will have to appear in written examination in subjects mentioned below followed by Viva-Voce to be conducted by the Arunachal Pradesh Public Service Commission.

Note: In order to qualify for interview, candidates must score an aggregate of 33% of the total marks in the written examination comprising of <u>three</u> papers, subject to condition that the candidate scores at least 20% in each Subject/ Paper of the written examination.

#### (D) APPLICATION FEE

Candidates are required to pay fee of ₹150/- (Rupees One Hundred Fifty) only for APST candidate and ₹200/- (Rupees Two Hundred) only for other candidate in form of IPO.

- 1. Latest/Recent color passport size photo. The photograph is to be in white background, front faced and without headgear and sunglasses.
- 2. Self-Attested photocopy of Degree certificates and Mark Sheets issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain degree.
- 3. Self-Attested photocopy of Matriculation Certificate for proof of age issued by the Board.
- 4. Self-Attested Photocopy of APST certificate and copy of PRC/Aadhar Card in case of General candidates.
- 5. Self- Attested photocopy of appointment order to the post.
- 6. IPO of amount deposited as fee.

# (F) LAST DATE FOR SUBMISSION OF APPLICATION: 30th October 2025 (Thursday)

#### NOTE:

- (1) The decision of the Commission as to the eligibility or otherwise of candidate for admission to written examination/interview or selection will be final and no correspondence or personal enquiry will be entertained.
- (2) Date for Written Examination is scheduled on **28**<sup>th</sup> **November 2025** (**Friday**). Date of Interview of eligible candidates shall be intimated separately.
- (3) Eligible candidates will have to produce the above-mentioned (at Point E) Certificates/Documents and Mark Sheets in original at the time of interview, failing which he/she shall not be allowed to appear in the interview.
- (4) The Selection will be provisional and subject to verification of requisite documents/ qualifications by the indenting department.
