ADVERTISEMENT CANCELLATION NOTICE

Reference is invited to the Advertisement No. PSC-R(B)/14/2018 dated 14th July,2022 published in the Daily local News Edition dated 15th July'2022 for filling up of 25 (twenty five) posts of Lecturer (DIET), Group B Gazetted, Non-Ministerial.

In the larger interest of all the aspiring candidates, earlier Advertisement notified vide No. PSC-R (B)/14/2018 **stands cancelled** on the following grounds:-

- 1. The advertisement was floated on 14th July, 2022 followed by unfortunate paper leakage fiasco at APPSC office and resignation of the members of the Commission making the office non-functional in all administrative matters for 02 years.
- 2. The advertisement was floated in 2022 and 02 (two) years have lapsed since then and fresh qualified aspirants will also be eligible. The Commission considers it necessary to provide an equal opportunity to all the eligible and qualified candidates so that suitable candidates are selected in the larger interest of the public.
- 3. The guidelines for Conduct of Examination 2017 has also been modified and updated. Thereby, the terms and conditions for conduct of examination have also changed since the earlier advertisement.
- 4. The applicants who have applied against the earlier Advertisement No. PSC-R (B)/14/2018 dated 14th July, 2022 **shall not be considered** for recruitment with the previous application. Such candidates **need to apply afresh** in the new application form. However, the examination fees paid while applying in the earlier advertisement as mentioned above can be adjusted for the fresh application. For adjusting the earlier fee, the applicant will have to upload their previous application form along with the fresh application for claim of fee exemption atleast 02(two) days (i.e 48 hours) before the last date for submission of the application.
