**(A) HOW TO APPLY**

(1) Before filling the Online Application Form for the post advertised, a candidate must mandatorily register for **ONE TIME REGISTRATION (OTR)**.

- (2) Those who have already registered in OTR need not register again and they can directly login to fill up online form using the same user ID and password.
- (3) Candidates are required to apply online on <https://appsc.gov.in>. Detailed instructions for One Time Registration (OTR) and Online Application are available on the APPSC website (<https://appsc.gov.in>). The applicants are advised to submit only single application, however, if due to any unavoidable situation, he/she submits another/multiple applications, the application with the highest Registration ID (RID) will be accepted by the Commission. Therefore, the highest RID application should be complete in all respects. The fee paid against one RID shall not be adjusted against any other RID.
- (4) Applicants in Government Service should also apply directly on the APPSC website. Such applicants have to upload a copy of intimation submitted to their respective Heads of Department or NOC issued by the department.

**Note: The online application submission link shall be active from 1600 Hrs on 16.08.2024 till last date of submission i.e before 1700 hrs on 04.09.2024 on the APPSC Website.**

**(B) EDUCATIONAL QUALIFICATION**

As per National Council of Teacher Education (NCTE) norms teacher educators in D.El Ed should have Master Degree in Social Science / Humanities/ Science/ Mathematics/ Language with 50% marks and M.Ed. with 50% marks or MA (Education) with 50% marks.

**(C) AGE LIMIT**

- (1) Not exceeding 35 years of age as on **04.09.2024**. However, the upper age limit is relaxable in accordance with the orders issued by the Government of Arunachal Pradesh from time to time.
- (2) Departmental candidates with 3 years of continuous service shall be given age relaxation of 5 years (five) in addition to the normal age relaxation of age for appointment to Group A and B posts by direct recruitment which are in the same line or allied cadres. The age relaxation shall be admissible where a relationship could be established that service already rendered in a particular post will be useful for the efficient discharge of the duties of the post (s) recruitment to which the same has been advertised.

**(D) METHOD OF SELECTION**

- (1) The selection will be made through Viva-voce/Interview.
- (2) In case the number of applicants is more than the desired ratio, the Commission may conduct a Recruitment Test, the details of which will be notified separately.
- (3) Recruitment Test, if conducted may be objective/subjective examination in concerned subject.
- (4) The tentative date for Recruitment Test, if conducted is scheduled on 29.09.2024.



(5) Recruitment test, if conducted then the candidate:

- a. applying for the post of Lecturer (DIET) in Science subject can choose to appear either in Biology, Physics or Chemistry papers.
- b. applying for the post of Lecturer (DIET) in Social Science subject can choose to appear either in Economics, Geography, History or Political science.

**(E) SCANNED DOCUMENTS AND INFORMATION TO BE UPLOADED**

- (1) Signature of the candidate on white paper with black ink pen (40-50 kb in jpg format).
- (2) Latest/Recent color passport size photo (40-100 kb in jpg format). The photograph is to be in white background, front faced and without headgear and sunglasses.
- (3) Self-Attested photocopy of Master Degree certificates and Mark Sheets issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain degree.
- (4) Self-Attested photocopy of Matriculation Certificate for proof of age issued by the Board only will be accepted.
- (5) Self-Attested Photocopy of APST certificate for APST candidates and Aadhar Card/PRC/EPIC for other applicants.
- (6) Person with Benchmark Disabilities (PwBD) candidates should submit disabilities certificate issued by the certifying authority as per Section 57 of Rights of Person with Disabilities Act, 2016.

**(F) APPLICATION FEE**

- (1) Candidates are required to pay fee of ₹150/- (Rupees One Hundred Fifty) only for APST candidate and Rs.200/- (Rupees two hundred) only for other Applicants.
- (2) PwD candidates are exempted from payment of application fee as per Section 19 of the Arunachal Pradesh Rights of Persons with Disabilities Rules, 2018

**(G) LAST DATE FOR SUBMISSION OF APPLICATION: 04.09.2024 (1700 Hours)**

**(H) INTERVIEW/VIVA-VOCE:**

Eligible candidates will have to produce the above-mentioned (at Point E) Certificates/Documents and Mark Sheets in **original** at the time of interview, failing which he/she will not be allowed to appear in the interview.

**NOTE:**

- (1) The decision of the Commission as to the eligibility or otherwise of candidate for admission to Recruitment Test/Interview/Selection will be final and no correspondence or personal enquiry will be entertained.



- (2) Date for the Recruitment Test/Interview of the eligible candidates will be intimated separately.
- (3) The selection will be provisional subject to verification of requisite documents/ qualifications by the indenting department.
- (4) In case of PwD candidates, the selection process will be as per the Right of persons with Disabilities Act, 2016 and Arunachal Pradesh Rights of Persons with Disabilities Rules, 2018 as amended from time to time.
- (5) The applicants who have applied against the earlier Advertisement No. PSC-R (B)/14/2018 dated 14<sup>th</sup> July, 2022 **shall not be considered** for recruitment with the previous application. Such candidates **need to apply afresh** in the new application form. However, the examination fees paid while applying in the earlier advertisement as mentioned above can be adjusted for the fresh application. For adjusting the earlier fee, the applicants are instructed to use the same login credentials/ID used for the previous application form **Or** upload their previous application form as a supporting document to claim fee exemption. However, the application has to be submitted atleast 2 days (i.e 48 hours) before the last date for submission of the application.
