2. The applicants included in the REJECTED list at Annexure -III can submit their grievance along with supporting documents on the APPSC website by **1100 hours on 26.09.2024** which shall be examined for consideration. In case the candidate fails to submit any supporting documents within the above-mentioned time their candidature shall be REJECTED.
3. To submit the deficit/legible documents, the candidate will have to login using own credentials in the One Time Registration link on the APPSC website.
4. The Written Examination shall be conducted on **4th and 5th October, 2024**.
5. The time and venue for examination shall be mentioned in the Admit Cards. The date for downloading of Admit Cards shall be notified separately.
6. The decision of the Commission with respect to the eligibility of the candidates for admission to the Written Examination shall be final.
