2.	Mechanical Engineering	2 (two) posts. Out of 2 (two) posts 1 (one) post is reserved for Physically handicapped candidate.
3.	Electronics/Telecommunication/ Computer Engineering	1 (one) post.

With the inclusion of the above 7 (seven) posts, the number of posts has increased from 15 to 22 posts.

Reservation of posts and nature/category of disability will be notified after receiving clarification from concern Govt. Department.
