The Arunachal Pradesh Public Service Commission invites online application from the Citizens of India for filling up of 55 (Fifty Five) posts of General Duty Medical Officer (GDMO) under the Department of Health and Family Welfare, Government of Arunachal Pradesh in the Pay Matrix in Level-10 (₹ 56,100/- to 1,77,500/-) as admissible under rule. (A) HOW TO APPLY

- (1) Before filling the Online Application Form for the post advertised, a candidate must mandatorily register for **ONE TIME REGISTRATION (OTR)**.
- (2) Those who have already registered in OTR need not register again and they can directly login to fill up online form using the same user ID and password.
- (3) Candidates are required to apply online on https://appsc.gov.in. Detailed instructions for One Time Registration (OTR) and Online Application are available on the APPSC website (https://appsc.gov.in). The applicants are advised to submit only single application; however, if due to any unavoidable situation, he/she submits another/multiple applications, the application with the highest Registration ID (RID) will be accepted by the Commission. Therefore, the highest RID application should be complete in all respects. The fee paid against one RID shall not be adjusted against any other RID.
- (4) Applicants in Government Service should also apply directly on the APPSC website. Such applicants have to upload a copy of intimation submitted to their respective Heads of Department or NOC issued by the department.

NOTE: The online application submission link shall be active from 1700 hours on 09.08.2024 till last date of submission i.e before 1700 hours on 29.08.2024 on the APPSC website. Tentative date of written examination is scheduled on 15.09.2024.

(B) AGE LIMIT

Not exceeding 35 years as on 29.08.2024. However, the upper age limit is relaxable in accordance with the orders issued by the Government of Arunachal Pradesh from time to time.

(C) METHOD OF SELECTION

The eligible candidate will have to appear in written examination (Objective Type) in the following subjects followed by Viva-Voce to be conducted by the Arunachal Pradesh Public Service Commission (APPSC) in accordance with the Arunachal Pradesh Health Services Rules-2000 and Government of Arunachal Pradesh, Department of Health and Family Welfare Notification vide No. MEST-2004/185 dated 29th March, 2010.

(D) SCANNED DOCUMENTS AND INFORMATION TO BE UPLOADED

- (1) Signature of the candidate on white paper with black ink pen (40-50 kb in jpg format).
- (2) Latest/Recent color passport size photo (40-100 kb in jpg format). The photograph is to be in white background, front faced and without headgear and sunglasses.
- (3) Self-Attested photocopy of Degree/Post Graduate/Post Graduate Diploma certificates and Mark Sheets issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain degree.
- (4) If due to non-holding of convocation the degree certificate cannot be submitted as proof of having passed the qualifying examination and for the candidates of recognized autonomous colleges, the marksheet/grade, issued by the Controller/Dy. Controller/Assistant Controller/Chief Controller of the examination of such recognized autonomous colleges shall only be accepted.
- (5) Self-Attested photocopy of Matriculation Certificate for proof of age issued by the Board only will be accepted.
- (6) Self-Attested Photocopy of APST certificate and copy of PRC/Aadhar Card in case of General candidates.
- (7) Self-Attested photocopy of Medical Council/Dental Council/Homeopathy Council Registration Certificate (not mandatory).
- (8) Person with Benchmark Disability (PwBD) candidates should submit disability certificate issued by the certifying authority as per Section 57 of Rights of Persons with Disabilities Act, 2016.

(E) APPLICATION FEE

- Candidates are required to pay fee of ₹150/- (Rupees One Hundred Fifty) only for APST candidate and ₹ 200/- (Rupees Two Hundred) only for other candidate through online mode only.
- (2) PwD candidates are exempted from payment of application fee as per Section 19 of the Arunachal Pradesh Rights of Persons with Disabilities Rules, 2018.
- (F) LAST DATE FOR SUBMISSION OF APPLICATION: 29.08.2024 (1700 Hours)

NOTE:

- (1) The decision of the Commission as to the eligibility or otherwise of candidate for admission to interview or selection will be final and no correspondence or personal enquiry will be entertained.
- (2) Date for the interview of the eligible candidates will be intimated separately.
- (3) Eligible candidates will have to produce the above-mentioned (at Point D) Certificates/Documents and Mark Sheets in original at the time of interview, failing which he/she will not be allowed to appear in the interview.
- (4) The Selection will be provisional and subject to verification of requisite documents/qualifications by the indenting department.
- (5) In case of PwBD candidates, the selection process will be as per the Rights of Persons with Disabilities Act, 2016 and Arunachal Pradesh Rights of Persons with Disabilities Rules, 2018 as amended from time to time.
- (6) In case, there are large number of applicants, the Commission if deemed necessary, may conduct Recruitment Test, the details of which will be notified separately.
