NOTIFICATION

In continuation to advertisement issued for Junior Engineer Common Recruitment Examination (JECRE)-2025 on 17th September 2025 and subsequent Notifications issued on 12th December 2025 and 17th December 2025, it is hereby notified that written examination of JECRE-2025 shall be conducted as scheduled on **11th January 2026**.


It is further notified that:

- 1) All applicants with deficit documents listed in Annexure-1 as notified earlier vide even number on 12th December 2025 are provisionally accepted on condition that self-attested copy of all relevant documents along with the original is submitted on the notified date before the day of interview, failing which their candidature shall be **REJECTED**. Those who are appearing in the final year of the examination will be allowed to appear in the interview only on the production of the proof of having passed the qualifying examination in as prescribed in the advertisement of **Clause B (2)**.
- 2) All applicants who have submitted Diploma/ Degree equivalent of Technician Engineer Membership/ Associate Membership (AMICE(I)), etc. from various institutes are provisionally accepted on condition that valid documentary proof issued by concerned authority in support of recognition of their course and institution is submitted on the notified date before the day of interview/ Viva-Voce. All such applicants who fail to submit such valid document shall be **REJECTED**.
- 3) After verification of claims received, application of following applicant who was earlier Rejected is now provisionally accepted:

- 4) The PwD applicants who did not submit valid Disability Certificate specifying Benchmark Disability from competent authority in prescribed/ standard format containing signatures of concerned Medical specialist shall NOT be considered for PwBD reservation.
- 5) Date for document verification shall be notified later. All such applicants who fail to submit copy of required documents on the notified date shall be **REJECTED** and **DISQUALIFIED** for appearing in the Interview/ Viva-Voce.
- 6) The ADMIT Card for written examination of JECRE-2025 shall be available for download in the APPSC website with effect from 24th December 2025 at 5:00 PM onwards till 8:00 AM on the day of exam.
