1. The applicants who have claimed to have fulfilled the eligibility conditions as per the Advertisement No. PSC-R(A)/15/2022 dated 30th April, 2024 but have not furnished the complete documents have been included in the **PROVISIONALLY ACCEPTED** list **only on the condition** that the deficit experience certificate/ relevant documents are to be uploaded on the APPSC website (Submission Form) by 1100 hrs on 26.07.2024 (Friday). In case the candidate fails to submit the documents till the mentioned time their candidature shall be rejected for the Viva-voce/interview.
2. The candidates as mentioned in the rejected list can submit their grievances or other relevant detail along with the supporting documents on the APPSC website (Submission Form) by 1100 hrs on 26.07.2024 (Friday) which shall be examined for consideration.
3. No further submission will be entertained with respect to the eligibility of candidates after 1100 hrs on 26.07.2024 (Friday).
4. The final list of eligible candidates for the Viva Voce/ Interview will be published on the website on 26.07.2024 (Friday) at 1700 hrs.
5. **The date of Interview/Viva Voce for the post of Junior Specialist (Allopathy) has been fixed on 2nd and/or 3rd August, 2024.** The details regarding the time and venue will be informed with the Call Letters/Admit Cards. The Call Letters/Admit Cards of the eligible candidates shall be available for downloading from the APPSC website on 26.07.2024 (Friday) at 1800 hrs.
6. Only those applicants who have completed 3 years of experience in the concerned speciality after obtaining post-graduate degree or 5 years experience after obtaining post graduate diploma **on or before 2nd August, 2024** and have submitted all the requisite documents in accordance to the conditions specified in the Advertisement No.PSC-R(A)/15/2022 dated 30th April, 2024 for the post of Junior Specialist (Allopathy) shall be eligible for appearing in the interview.
7. The decision of the Commission with respect to the eligibility of the candidates for the Viva Voce/ Interview shall be final.
