MEDICAL SPECIALIST RECRUITMENT-2026

The Arunachal Pradesh Public Service Commission invites online application from the Citizens of India for filling up of **115 (one hundred fifteen)** posts of **Junior Specialist (Allopathy)** and **2 (two)** posts of **Junior Dental Specialist**, under the Department of Health & Family Welfare, Govt. of Arunachal Pradesh in the Pay Matrix Level-11 (₹ 67,700 - 2,08,700/-) as admissible under rule. NOTE: The number of vacancies, reservations for APST and PwBD candidates including disability criteria under PwBD reservation are as per "Proforma of Requisition" submitted by the Department of Health and Family Welfare, Government of Arunachal Pradesh.

A. HOW TO APPLY

- (1) Before filling the Online Application Form for the post advertised, a candidate must mandatorily register for **ONE TIME REGISTRATION (OTR)**.
- (2) Those who have already registered in OTR need not register again and they can directly login to fill up online form using the same user ID and password.
- (3) Candidates are required to apply online on <https://appsc.gov.in>. Detailed instructions for One Time Registration (OTR) and Online Application are available on the APPSC website (<https://appsc.gov.in>).
- (4) Applicants in Government Service have to upload a copy of intimation submitted to their respective Heads of Department or NOC issued by the department.
- (5) The applicants are advised to submit only single application, however, if due to any unavoidable situation, he/she submits another/multiple applications, the application with the highest Registration ID (RID) will be accepted by the Commission. Therefore, the highest RID application should be complete in all respects. The fee paid against one RID shall not be adjusted against any other RID.
- (6) The online application submission link shall be active from **1700 hours on 17th April, 2026** till last date of submission i.e. before **1700 hours on 18th May, 2026** on the APPSC website.
- (7) **The candidates should carefully fill the requisite details in the online application form. The application form once submitted within the last date of submission should be complete in all respects and no additional time shall be provided to the candidate to further change or upload additional information. The candidates are requested to minutely go through the DISCLAIMER provided in the online application form before final submission of form. Any information found to be wrong or not in conformity to the conditions laid in the Recruitment Rules or other relevant Govt. Rules at any stage of examination may lead to cancellation of candidature for Medical Specialist Recruitment-2026.**

B. EDUCATIONAL QUALIFICATION AND ELIGIBILITY CRITERIA

I. Junior Specialist (Allopathy)

- i. A recognized medical qualification included in the First or Part-II of the Third Schedule (other than licentiate qualification) of the Indian Medical Council Act, 1956. Holders of educational qualification included in the Part-II of the Third Schedule should also fulfill the condition stipulated in sub-section (3) of the section (13) of the Indian Medical Council Act, 1956.
- ii. Post-Graduate Degree in the concerned specialty mentioned in Section 'A' or Section 'B' or Section 'D' as the case may be in Schedule VI or equivalent of Arunachal Pradesh Health Service Rules, 2000.
- iii. The candidate (including Foreign Medical Graduates/Post Graduates) must be registered with Arunachal Pradesh Medical Council (APMC).

II. Junior Dental Specialist

- i. Medical qualification included in the Part-I or Part-III of the Schedule to the Dentist Act, 1948 as amended from time to time.
- ii. Post-graduate degree in concerned specialty mentioned in Section 'A' or Section 'B' or Section 'D' as the case may be in Schedule-VI or equivalent of Arunachal Pradesh Health Service Rules, 2000.
- iii. The candidate (including Foreign Medical Graduates/Post Graduates) must be registered with Arunachal Pradesh Dental Council (APDC).

NOTE: The Government of Arunachal Pradesh has given One Time Relaxation of the provision(s) in column 3 and 4, II(2) Part-III of the Schedule-V of Arunachal Pradesh Health Services Rules, 2000, waiving off 3(three) years' experience in the concerned Speciality after obtaining Post Graduate degree and 5(five) years' experience in the concerned Speciality after obtaining Post Graduate Diploma vide GoAP Notification No. DMETR-11012(17)/1/2024 dated 7th February, 2026 .

C. AGE LIMIT

- (1) In accordance with One Time Relaxation on the upper age limit vide GoAP Notification No. DMETR-11012(17)/1/2024 dated 7th February, 2026, the candidate must not exceed 50 years (Relaxable for Government Servants by 05 years) as on last date of submission of online application form (18th May, 2026).
- (2) Age concession in respect of candidates belonging to PwBD Category and regular Government servant of Government of Arunachal Pradesh will be as per Government rules and regulation in force from time to time.

D. METHOD OF SELECTION

- (1) The selection will be made through Viva-Voce/Interview only in accordance with the Arunachal Pradesh Health Service Rules-2000 amended vide Notification No.HFW-1/89(Pt) dated 31/10/2003. The total marks of Interview shall be 100 marks.
- (2) In accordance with provision under the Rule XI, Sub-rule (e) of APPSC Manual for Conduct of Examination-2024, in case of direct recruitment by interview only, a candidate has to score a minimum of 50% of the total marks in the interview to qualify for selection. Relaxation for PwBD candidates, if any, shall apply as per the Government notification.

E. SCANNED COPIES OF FOLLOWING DOCUMENTS AND INFORMATION ARE TO BE SUBMITTED WITH ONLINE APPLICATION FORM

- (1) Signature of the candidate on white paper with black ink pen (40-50 kb in jpg format).
- (2) Latest/Recent color passport size photo (40-100 kb in jpg format). The photograph is to be in white background, front faced and without headgear and sunglasses.
- (3) Self-Attested photocopy of Matriculation Certificate/Marksheet with Date of Birth mentioned issued by the Board for proof of age. **No other document shall be accepted as proof of Date of Birth.**
- (4) Self-Attested Photocopy of Arunachal Pradesh Scheduled Tribe (APST) certificate (to avail reservation under APST category) for APST candidates.
- (5) Self-Attested photocopy of Aadhar Card/PRC/EPIC as identity proof for non-APST applicants.
- (6) Self-Attested photocopy of Bachelor Degree certificates and Mark Sheets issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain degree.
- (7) Self-Attested photocopy of Master Degree certificates and Mark Sheets issued by the Assistant Registrar/Registrar/Controller of Examination/Vice-Chancellor of the concerned University to ascertain post graduate degree.
- (8) Experience Certificate in the concerned speciality, if any.
- (9) Person with Disability (PwD)/Person with Benchmark Disability (PwBD) candidates should submit disability certificate issued by the certifying authority as per Section 57 of Rights of Persons with Disabilities Act, 2016, failing which, such candidates shall not claim the reservation under PwBD category and shall not be entitled for any concession. In the Medical Board, the Medical Specialist of the particular disability, for which certificate is sought, must be a member. **The Disability Certificate must clearly mention the Percentage of Disability. The date of issuance of the Disability Certificate should be before the last date of submission of online application form.** Otherwise, the Disability Certificate will not be accepted for claiming reservation under PwBD category.
- (10) Self-Attested photocopy of Arunachal Pradesh Medical Council Registration Certificate or Arunachal Pradesh Dental Council Registration Certificate.

F. APPLICATION FEE

- (1) APST candidates are required to pay fee of ₹ 150/- (Rupees One Hundred Fifty) only and ₹200/- (Rupees Two Hundred) only for other applicants.
- (2) PwBD candidates are exempted from payment of application fee as per Section 19 of the Arunachal Pradesh Rights of Persons with Disabilities Rules, 2018.

G. LAST DATE FOR SUBMISSION OF APPLICATION: 18th May, 2026 (1700 Hours).

NOTE:

- (1) Candidates will be shortlisted for interview on the basis of information provided at the time of submission of online application form. Therefore, it is the responsibility of the candidate to prove his/her eligibility for the post with respect to the eligibility criteria mentioned in this advertisement.
- (2) The candidature of a candidate at any stage of the examination is provisional and subject to notification/direction/decision/order/pronouncement of the Government or any Court of Law. Mere issuance of Admit Card or appearance at the selection process does not entitle the candidate to any claim for the post.
- (3) Candidates falling under the Persons with Benchmark Disability (PwBD) category with 40% and above percentage of disability must ensure compliance with the functional requirements prescribed for the post(s) for which the candidate intends to apply. The selection process will be as per the Right of persons with Disabilities Act, 2016 and Arunachal Pradesh Rights of Persons with Disabilities Rules, 2018 as amended from time to time.
- (4) Eligible candidates will have to produce the above-mentioned (at Point E) Certificates/Documents and Mark Sheets in **ORIGINAL** at the time of interview. If a candidate is found not to be eligible during the document verification prior to the interview, his/her candidature shall be **REJECTED** and he/she shall not be allowed to appear in the interview.
- (5) The decision of the Commission as to the eligibility or otherwise of a candidate shall be final and no correspondence or personal enquiry will be entertained.
- (6) **Date for the Interview of the eligible candidates will be notified in due course.**
- (7) The candidate must note that the Appointing Authority, that is, the Indenting/ Requisitioning Department conducts the medical test and verifies the character and antecedents of the candidates, authenticity of all the documents/certificates, authenticity of the disability certificates and eligibility as per the Recruitment Rules before finally appointing the candidates. Therefore, the provisional recommendation of a candidate does not confer upon him/her any right to appointment unless the Appointing Authority is satisfied, after such inquiry as maybe considered necessary, that the candidate is suitable for the appointment to the post.


