**ASSISTANT PROFESSOR EXAMINATION-2026**

**Subject: Botany**

In pursuance of APPSC Advertisement No. 01/2026 vide Notification No. PSC-R(B)/01/2025 dated 22nd January, 2026 for the post of Assistant Professor in various disciplines for Government Colleges under the Department of Education, Government of Arunachal Pradesh, the online applications received were scrutinized. The detailed list of applicants for the subject of **Botany (Annexure-I/1, I/2 and I/3)** whose applications have cleared the first level of verification (Annexure-I/1), those having deficit documents (Annexure-I/2) and those whose applications have been **REJECTED** (Annexure-I/3) are enclosed herewith under the following terms and conditions:

1. The applicants included in the list at **ANNEXURE-I/2** have to submit the deficit documents before **5.00 PM on 19<sup>th</sup> June, 2026**. To submit the deficit/legible document, the online application link of the candidates will be opened with effect from **12.00 PM on 13<sup>th</sup> June, 2026**. The candidates have to login using own credentials in the One Time Registration (OTR) on the APPSC website and submit the deficit documents on the online application link. In case the candidate fails to submit the documents within the above-mentioned time his/her candidature may be rejected.
2. The applicants included in the **REJECTED** list at **ANNEXURE-I/3** can submit their grievances along with supporting documents to the APPSC on email id [appsc.helpdesk-arn@gov.in](mailto:appsc.helpdesk-arn@gov.in) by **5.00 PM on 19<sup>th</sup> June, 2026** which shall be examined for consideration. In case the candidate fails to submit any supporting documents within the above-mentioned time their candidature shall stand **REJECTED**.
3. The **Provisional Academic Scoresheet** prepared in accordance with **Appendix II Table 3B** of UGC Regulation, 2018 of all the candidates listed at **Annexure-I** shall be uploaded on their respective OTR with effect from **12.00 PM on 13<sup>th</sup> June, 2026**. The candidates are requested to carefully verify the same and submit any claims and objection with regards to their score alongwith documentary proof to the APPSC. The claims are to be uploaded on their respective online application link by login to their OTR. The online application link shall be active from **12.00 PM on 13<sup>th</sup> June, 2026 to 5.00 PM on 19<sup>th</sup> June, 2026**.
4. No further submission will be entertained with respect to the Academic Score and eligibility of candidates after **5.00 PM on 19<sup>th</sup> June, 2026**. All submission must be made online. No physical or hard-copy submissions will be accepted.
5. The scrutiny report and provisional academic scoresheet of remaining subjects shall be released phase wise on the APPSC website.
6. **The final list of the eligible candidates shortlisted for appearing in the Viva-Voce/Interview will be notified on the website subsequently.**
7. The decision of the Commission with respect to the eligibility of the candidates for admission to the Viva-Voce/Interview of the Assistant Professor Examination-2026 shall be final.


