Hence, Contractual employee will not be entitled to concession of age relaxation as provided to regular Government employee.

However, if and is in the category of SC/ST and is also in government service under the government of Arunachal Pradesh, he is entitled to both the relaxations. Action may be taken accordingly.

No. AR-28/13.—In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Arunachal Pradesh is hereby pleased to make the following rules to regulate the upper age-limit for direct recruitment to the Arunachal Civil Services and Civil Posts under the Government of Arunachal Pradesh, namely :—

1. Short title and commencement : (1) These rules may be called the Arunachai Civil Services and Civil Posts (Upper Age-Limit for Direct Recruitment) Rules, 2014.

(2) They shall come into force on their date of publication in the official Gazette of Arunachal Pradesh.

2. Application : (1) These rules shall apply to Arunachal Civil Services and Civil Posts under the State Government of Arunachal Pradesh.

(2) These rules shall not apply to direct recruitment to any State Civil Services or Civil Posts under the Government of Arunachal Pradesh for which actions for recruitment is initiated through open advertisement or otherwise before the date of publication of this rule.

(3) These rules shall not apply also to recruitment to executive post(s) in uniform services namely, Arunachal Pradesh Civil Police, Arunachal Armed Police Battalion, India Reserve Battalion, Wireless and Telecom, Fire Service, Jail Service, Range Forest Officer, Forester, Forest Guard, Special Tiger Force/Inspector Tax and Excise, Assistant Inspector Tax and Excise and Constable Tax and Excise where physical training is mandatory.

3. Age : The age for direct recruitment by the method of direct open competitive examinatito the State Civil Services and Civil Posts shall be 18 to 30 years.

4. Amendment of Recruitment Rules : All rules regulating the method of recruitment of person to Arunachal Civil Services and Civil Posts under the Government of Arunachal Pradesh governing Open Competitive Examination shall stand amended to the extent provided for in Rule - 3.

5. Interpretation : If any question arises as to the interpretation of these rules, the same shall be decided by the State Government.

6. Categories of persons and extent of concessions : Certain age concessions have in the past been sanctioned to few specified categories of person for the purpose of appointment to Civil Services/Civil Posts under the Government of Arunachal Pradesh. These concessions are Still in force until further orders. Details of the categories of person and age concession admissible to them are as given below :-
