This is to notify that, the **Limited Departmental Competitive Examination (LDCE) 2026**, for filling up of **7(Seven) posts of Senior Personal Assistant (SPA)** under APSS (General Cadre) through LDCE is scheduled to be held on **7th October 2026**.

METHOD OF SELECTION

The Scheme of Examination for selection of candidates for recruitment to the post of Stenographer Grade-II/SPA through LDCE will comprise of a **Stenography Proficiency Test (English)**. The norms of Stenography Proficiency Test as per Recruitment Rule are:

- Dictation (English): -Stenography Proficiency Test will be conducted for 5 minutes at the speed of 100 Words Per Minute (WPM)
- Transcription: - 60 minutes (English), Skill Test shall be done on computer. An average of 5 key depression for each word.
- Following permissible mistakes in transcription would apply in Stenography Proficiency Test in respect of candidates belonging to: -
 - For candidates(s) belonging to General Category-8%
 - for candidates(s) belonging to APST Category-10%

The call letter of eligible candidates as per General Administration Department letter no. GAD-34/2023/2730 dated 14th August 2026 shall be e-mailed in the mail ID provided in their application form. In addition, the same may be collected in person or via an authorized individual from the Commission's office w.e.f **14/09/2026 to 18/09/2026** during office hours from the Receipt/Dispatch Section in the Ground Floor of APPSC New Building, Itanagar.
