1. Candidates should carry the copy of the Admit Card downloaded from the APPSC website along with the original copy of the ID card which is mentioned in the Admit Card.
2. No entry into the examination venue will be permitted after 08:45AM (forenoon session) and 1:45 PM (afternoon session).
3. There will be no parking at the vicinity of the Examination Venues. Therefore, candidates should manage their time accordingly and reach exam centre at the earliest.
4. All candidates should mandatorily go through frisking booth/counter while entering the venue and get their biometric details captured for each session.
5. Prohibited items in the examination venue include mobile phones, bluetooth devices, electronic gadgets etc and any other stationaries/ objectionable items. Hence, do not carry them.

6. Candidates are allowed to carry a Non-Programable Calculator on **10.04.2025** for Optional Paper-I and Optional Paper-II, if required. However, the calculator should be without cover and memory of the calculator should be deleted. No marking should be made on the calculator or else the candidate's calculator may be seized at the entrance.
7. The candidates are allowed to carry NON-METALLIC and TRANSPARENT blue/black pen. The pen of the candidate shall be seized if it does not confirm to the above specifications.
8. A candidate who is ABSENT in any of the Papers shall not be allowed to sit in the subsequent Papers.
9. Candidates should read instructions on the Question-cum-Answer Booklet carefully before filling up the Question-cum-Answer Booklet.
10. Candidates will not be permitted to leave the examination hall before completion of the exam period.
11. The Commission has notified the minimum qualifying marks for the written examination of APPSCC(M)E-2024 and same is available on the APPSC website.
