POST GRADUATE TEACHER EXAMINATION- 2025

In pursuance of advertisement No. PSC-R (A)/01/2025 dated 16th August 2025 for the post of Post Graduate Teacher and in continuation of the earlier notification vide even no. dated 14th October 2025, the final list of **PROVISIONALLY ACCEPTED** (Annexure-I), **REJECTED** (Annexure-II) candidates are enclosed with the following terms & conditions:

- 1. The applicants included in the **PROVISIONALLY ACCEPTED** list at **ANNEXURE-I** shall be admitted for the Recruitment Test. However, their candidature is provisional subject to the condition that legible/deficit documents/clarification mentioned against their names vide Notification No. PSC-R(A)/01/2025 dated 14th October, 2025 are submitted before Written Examination (Mains), if they qualify in the Recruitment Test. In case the candidate fails to submit the documents/clarification, their candidature for the next stage of examination may be rejected.
- 2. The candidates who have submitted M.Sc. (Biotechnology), MA (Archaeology), MA (Ancient History, Archaeology & Culture) Degree Certificates are PROVISIONALLY ACCEPTED subject to receipt of clarification from the indenting/requisitioning departments.
- 3. Further scrutiny of applications and documents of all candidates selected in Recruitment Test will be conducted at a later stage.
- 4. It is informed that due to administrative reasons Ziro has been dropped as an examination centre. Candidates who had opted for Ziro as their first preference for examination centre shall be allotted in examinations centres of ICR.
- 5. The Admit Card of eligible candidate shall be available for download subsequently.
- 6. The decision of the Commission with respect to the eligibility of the candidates for admission to the Recruitment Test shall be final.
