In continuation to Result Notification vide even number, Date: 28<sup>th</sup> January 2026 and document verification conducted for Junior Engineer Common Recruitment Examination-2025, it is hereby informed that the interview/ Viva-Voce is scheduled from 30<sup>th</sup> March 2026 onwards.

Admit Card for admission to the interview/ viva-voce shall be available for download to all eligible Candidates from **5:00 PM on 24/03/2026**.

All Candidates should mandatorily bring their Admit Card and the original copy of the ID Card mentioned in their application form/ Admit Card.

All Candidates belonging to PwBD category requiring communication aid for interview must submit a representation in the prescribed format enclosed herewith in **APPENDIX-I**. All such representation should be sent through mail ([appsc.helpdesk-arn@gov.in](mailto:appsc.helpdesk-arn@gov.in)) latest by 26/03/2026.

Candidates who did not submit their original Diploma / Degree Pass Certificate and their Final Semester Marksheet at the time of document verification earlier must bring the same on the day of interview / viva-voce for verification, failing which they shall not be allowed for interview/ viva-voce.

Additionally, **103** Candidates of Civil/ Agricultural engineering from the **Wait List** are also called for interview/ viva-voce against the absentee candidates in document verification of JECRE-2025. The Roll Numbers of Candidates from the wait-list found eligible for the interview / viva-voce is listed in **APPENDIX-II**. Document verification of these Candidates shall be conducted on the day of interview / viva-voce. Hence, they should mandatorily bring all the required documents in original and a separate set of photo-copy of all required documents on the day of their interview.
